A BILL FOR AN ACT

To further amend Public Law No. 10-119, as amended by Public Laws Nos. 10-124, 10-128, 10-130, and 10-132, by further amending section 2, as amended by Public Law No. 10-128, to appropriate the amount of \$59,000 from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 1999, as supplemental funding for Congress and to reprogram funds between expenditure categories, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 2 of Public Law No. 10-119, as amended by
2 Public Law No. 10-128, is hereby further amended to read as follows:

3 "Section 2. Operating expenses of the Legislative Branch.

4 The sum of \$~~[2,757,345]~~ 2,816,345, or so much thereof as
5 may be necessary, is hereby appropriated from the General
6 Fund of the Federated States of Micronesia for the fiscal
7 year ending September 30, 1999, for the operations of the
8 Legislative Branch of the National Government of the
9 Federated States of Micronesia during fiscal year 1999.

10 The sum appropriated by this section shall be apportioned
11 as follows:

 - 13 (a) Personnel expenses\$ 407,700
 - 14 (b) Travel 424,800
 - 15 (funds may also be used for the chartering of
 - 16 vessels to outer islands, and up to \$1,800 of
 - 17 funds may be used for provisioning, representation
 - 18 and related expenses incurred in outlying island
 - 19 travel in the State of Pohnpei during fiscal year
 - 20 1998)
 - 21 (c) Contractual services, grants,
