## AN ACT

To further amend title 55 of the Code of the Federated States of Micronesia, as amended, by amending section 804, as enacted by Public Law No. 10-121, for the purpose of providing for certain instances in which the Chuuk State Commission on Improvement Projects shall serve as allottee, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1	Section 1. Section 804 of title 55, as enacted by Public Law
2	No. 10-121, is hereby amended to read as follows:
3	"Section 804. Chuuk State Development Authorities.
4	Where an appropriation designates a 'Development
5	Authority' as an allottee in Chuuk State, the designation
6	shall refer to an entity created by Chuuk State law. In
7	the event that such an entity has not been created by
8	Chuuk State law or has been abolished, the executive
9	director of the Chuuk State Commission on Improvement
10	Projects or his designee shall serve as allottee."
11	Section 2. This act shall become law upon approval by the
12	President of the Federated States of Micronesia or upon its becoming
13	law without such approval.

## A BILL FOR AN ACT

EΕ	IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:
1	Section 1. Section 804 of title 55, as enacted by Public Law
2	No. 10-121, is hereby amended to read as follows:
3	"Section 804. Chuuk State Development Authorities.
4	Where an appropriation designates a 'Development
5	Authority' as an allottee in Chuuk State, the designation
6	shall refer to an entity created by Chuuk State law[, or,
7	except as otherwise provided by law,]. [i]In the event
8	that such an entity has not been created by Chuuk State
9	law or has been abolished, [it shall refer to the Project
10	Coordinator for the region or district that is the
11	recipient of such appropriation, which shall be a person,
12	association of persons, or other entity based in the
L3	district or region and qualified by the Secretary of the
14	Department of Finance and Administration to act as
15	allottee] the executive director of the Chuuk State
16	Commission on Improvement Projects or his designee shall
17	serve as allottee."
18	Section 2. This act shall become law upon approval by the President
19	of the Federated States of Micronesia or upon its becoming law without
20	such approval.
