A BILL FOR AN ACT

To appropriate the sum of \$900,590 from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 2000, for the purpose of funding pre-convention expenses related to the Constitutional Convention, the Constitutional Convention itself, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. The sum of \$480,162, or so much thereof as may be  
2 necessary, is hereby appropriated from the General Fund of the  
3 Federated States of Micronesia for the fiscal year ending September  
4 30, 2000, for the purpose of providing for the conduct of the  
5 election of delegates, the travel and per diem expenses of the pre-  
6 convention committee, and other pre-convention expenses.

7 Section 2. The sum appropriated under section 1 of this act  
8 shall be apportioned as follows:

9	(1) Pre-convention committee per diem, travel,	
10	and other expenses .....	\$ 102,296
11	(2) Election of Delegates from Yap .....	60,345
12	(3) Election of Delegates from Chuuk .....	116,630
13	(4) Election of Delegates from Kosrae .....	30,000
14	(5) Election of Delegates from Pohnpei .....	70,891
15	(6) Director's Office .....	100,000

16 Section 3. The sum of \$420,428, or so much thereof as may be  
17 necessary, is hereby appropriated from the General Fund of the  
18 Federated States of Micronesia for the fiscal year ending September  
19 30, 2000, for the purpose of funding the Constitutional Convention.

20 Section 4. Allotment and management of funds and lapse date.

21 (1) All funds appropriated by this act shall be allotted,  
22 managed, administered, and accounted for in accordance with  
23 applicable law, including, but not limited to, the Financial  
24 Management Act of 1979. The allottee of the funds appropriated by  
25 this act shall be the President of the Federated States of



1 Micronesia or his designated representative who shall be responsible  
2 for ensuring that these funds, or so much thereof as may be  
3 necessary, are used solely for the purpose specified in this act,  
4 and that no obligations are incurred in excess of the sum  
5 appropriated.

6 (2) The authority of the allottee to obligate funds  
7 appropriated by this act shall lapse as of September 30, 2000.

8 Section 5. This act shall become law upon approval by the  
9 President of the Federated States of Micronesia or upon its becoming  
10 law without such approval.
