A BILL FOR AN ACT

To further amend Public Law No. 8-118, as amended by Public Laws Nos. 8-136, 8-138, 9-023 and 10-18, by further amending section 1, as amended by Public Laws Nos. 8-136 and 10-18 and by further amending section 3, as amended by Public Laws Nos. 8-138, 9-023 and 10-18, to modify the use of certain funds in the Western, Namonuito, and Hall Islands of Chuuk State, to change an allottee, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 1 of Public Law No. 8-118, as amended by
2 Public Laws Nos. 8-136 and 10-18, is hereby further amended to read
3 as follows:

4 "Section 1. The sum of \$446,120, or so much thereof as
5 may be necessary, is hereby appropriated from the General
6 Fund of the Federated States of Micronesia for the fiscal
7 year ending September 30, 1995, for the purpose of
8 constructing and/or improving roads, docks and/or
9 airports and funding other economic or social projects in
10 Chuuk State. The sum appropriated under this section
11 shall be apportioned as follows:

7 Section 2. Section 3 of Public Law No. 8-118, as amended by
8 Public Laws Nos. 8-138, 9-023 and 10-18, is hereby further amended
9 to read as follows:

10 "Section 3. Allotment and management of funds and lapse
11 date.

12 (1) All funds appropriated by this act shall be
13 allotted, managed, administered, and accounted for in
14 accordance with applicable law, including, but not
15 limited to, the Financial Management Act of 1979. The
16 allottee of the funds appropriated under subsection (1)
17 of section 1 of this act shall be the President of the
18 Federated States of Micronesia. The allottee of the
19 funds appropriated under subsection (2) of section 1 of
20 this act shall be the Northern Namoneas Development
21 Authority. The allottee of the funds appropriated under
22 subsection (3) of section 1 of this act shall be the
23 Lower Mortlocks Development Authority. The allottee of
24 the funds appropriated under subsection (4)(a) [7] of
25 section 1 of this act shall be the Northwest Project
