

A BILL FOR AN ACT

To further amend Public Law No. 9-052, as amended, by amending section 1 to change the use of Chuuk Election District No. 1 funds, by amending section 6 to change the allottee of these funds and to remove a consultation requirement, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 2 of Public Law No. 10-143, as
2 amended by Public Law No. 12-5 and 12- , is hereby further
3 amended to read as follows:
4 "Section 2. The sum of \$600,000, or so much
5 thereof as may be necessary, is hereby appropriated
6 from the General Fund of the Federated States of
7 Micronesia for the fiscal year ending September 30,
8 1999, for the purpose of meeting the needs of
9 primary and secondary public schools, providing
10 undergraduate and graduate student scholarships,
11 State hospitals and State administered public
12 health programs, and other social and economic
13 development projects and programs in the State of
14 Pohnpei. The funds appropriated by this section
15 for educational, hospital and public health
16 purposes, shall not be disbursed for salaries,
17 travel, training, or vehicles. The funds
18 appropriated under this section shall be

1 apporportioned as follows:

19 thereof. Section 1. Section 1 of Public Law No. 9-052, as amended
20 by Public Laws Nos. 10-46, 10-69, 10-106, 11-29 and 11-61, is
21 hereby further amended to read as follows:

22 "Section 1. The sum of \$5,500,000, or so much thereof
23 as may be necessary, is hereby appropriated from the
24 General Fund of the Federated States of Micronesia for
25 the fiscal year ending September 30, 1996, for the

1 purpose of funding infrastructure needs, transportation
 2 systems, and other economic and social projects, public
 3 projects and for other purposes in Chuuk State and for
 4 Chuukese outside of Chuuk State. The funds appropriated

4 Section 2. Section 6 of Public Law No. 9-052, as amended by
5 Public Law No. 10-69, is hereby further amended to read as
6 follows:

7 "Section 6. Allotment and management of funds and lapse
8 date.

9 (1) All funds appropriated by this act shall be
10 allotted, managed, administered and accounted for in
11 accordance with applicable law, including, but not
12 limited to, the Financial Management Act of 1979. The
13 allottee of the funds appropriated under subsections
14 (1)(a) and (1)(b) of section 1 of this act shall be the
15 President of the Federated States of Micronesia. The
16 allottee of the funds appropriated under subsection
17 (1)(c) of section 1 of this act shall be the Governor of
18 the State of Chuuk. The allottee of the funds
19 appropriated under subsection (1)(d) of section 1 of
20 this act shall be the Director of the Department of
21 Health Services, Chuuk State. The allottee of the funds
22 appropriated under subsection (2) of section 1 of this
23 act shall be the executive director of the Chuuk Housing
24 Authority. The allottee of the funds appropriated under
25 subsection (3) of section 1 of this act shall be the

1 ~~[Lower Mortlocks Development Authority]~~ Vice President
2 of the Federated States of Micronesia. The allottee of
3 the funds appropriated under subsection (4) of section 1
4 of this act shall be the Southern Namoneas Development
5 Authority. ~~[The funds appropriated under subsection (4)~~
6 ~~of section 1 of this act shall not lapse.]~~ The
7 allottee of the funds appropriated under subsections
8 (5)(a), (5)(b) and (5)(c) of section 1 of this act shall
9 be the Tolensom Authority. The allottee of the funds
10 appropriated under subsections (5)(d), (5)(e), (5)(f)
11 and (5)(g) of section 1 of this act shall be the Mayor
12 of Polle Municipality. The allottee of the funds
13 appropriated under subsection (6) of section 1 of this
14 act shall be the Northern Namoneas Development
15 Authority. The allottee of the funds appropriated under
16 subsection (7) of section 1 of this act shall be the
17 Northwest Islands Project Coordinator. The allottee of
18 the funds appropriated under subsections (1)(b)(i) and
19 (1)(b)(iii) of section 2 of this act shall be the
20 National Planner of the Federated States of Micronesia.
21 The allottee of the funds appropriated under subsections
22 (1)(b)(ii) and (1)(b)(v) of section 2 of this act shall
23 be the Chief Magistrate of Sokehs. The allottee of the
24 funds appropriated under subsections (1)(b)(iv) of
25 section 2 of this act shall be the National Planner of

1 the Federated States of Micronesia. The allottee of the
2 funds appropriated under subsection[~~s~~] (1)(c) of section
3 2 of this act shall be the Mayor of Kolonia Town. The
4 allottee of the funds appropriated under subsection
5 (1)(d) of section 2 of this act shall be President of
6 the Federated States of Micronesia or his designee. The
7 allottee of the funds appropriated under subsections
8 (1)(e) of section 2 of this act shall be the Chief
9 Magistrate of Nukuoro. The allottee of the funds
10 appropriated under subsection (1)(f) of section 2 of
11 this act shall be the Pohnpei Port Authority. The
12 allottee of the funds appropriated under subsections
13 (1)(a) and (3) of section 2 and subsections (2) and (3)
14 of section 3 of this act shall be the President of the
15 Federated States of Micronesia or his designee, except
16 that the allottee of the funds appropriated under
17 subsections (3)(a), (3)(b), (3)(c) and (3)(d) of section
18 2 of this act shall be the Pohnpei Transportation
19 Authority. The allottee of the funds appropriated under
20 subsections (1) and (4) of section 3 of this act shall
21 be the Governor of the State of Kosrae or his designee.
22 The allottee of the funds appropriated under subsections
23 (5)(a), (7) and (8) of section 3 of this act shall be
24 the Mayor of Lelu Municipality. The allottee of the
25 funds appropriated under subsection (5)(b) of section 3

1 of this act shall be the Mayor of Tafunsak Municipality.
2 The allottee of the funds appropriated under subsection
3 (5)(c) of section 3 of this act shall be the Mayor of
4 Utwe Municipality. The allottee of the funds
5 appropriated under subsection (5)(d) of section 3 of
6 this act shall be the Mayor of Malem Municipality. The
7 allottee of the funds appropriated under subsection (6)
8 of section 3 of this act shall be the Speaker of the
9 Congress of the Federated States of Micronesia or his
10 designee. The allottee of the funds appropriated under
11 subsection (6) of section 4 of this act shall be the
12 Mayor of Rull Municipality. The allottee of the funds
13 appropriated under the other subsections of section 4 of
14 this act shall be the Governor of the State of Yap or
15 his designee[; ~~PROVIDED that no funds shall be obligated~~
16 ~~or disbursed under subsection (1) of section 2 of this~~
17 ~~act without prior consultation with the member of the~~
18 ~~Pohnpei State Delegation to the Congress of the~~
19 ~~Federated States of Micronesia representing Pohnpei~~
20 ~~Election District No. 1, and that no funds shall be~~
21 ~~obligated or disbursed under subsection (13) of section~~
22 ~~4 of this act prior to consultation with a member of the~~
23 ~~Yap State Congressional Delegation to the Congress of~~
24 ~~the Federated States of Micronesia]. The allottees of
25 funds apportioned under subsection (1) of section 2 of~~

1 this act shall not obligate or expend any of said funds
2 for travel. The allottees shall be responsible for
3 ensuring that these funds, or so much thereof as may be
4 necessary, are used solely for the purpose specified in
5 this act, and that no obligations are incurred in excess
6 of the sum appropriated.

7 (2) The authority of the allottees to obligate funds
8 appropriated by this act shall not lapse."

9 Section 3. This act shall become law upon approval by the
10 President of the Federated States of Micronesia or upon its
11 becoming law without such approval.
