

A BILL FOR AN ACT

To further amend Public Law No. 11-27, as amended, by amending section 1 for the purpose of creating an Infrastructure Projects, Roads, and Other Economic and Social Projects and Programs Trust Fund for Chuuk State Election District No. 4, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 1 of Public Law No. 11-27, as amended by
2 Public Law No. 11-65, is hereby further amended to read as follows:

3 "Section 1. The sum of \$3,000,000, or so much thereof as may
4 be necessary, is hereby appropriated from the General Fund of
5 the Federated States of Micronesia for the fiscal year ending
6 September 30, 2000, for the purpose of funding infrastructure
7 projects, roads, and other economic and social projects and
8 programs in the State of Chuuk. The funds appropriated under
9 this section shall be apportioned as follows:

- 10 (1) Chuuk state-wide projects.....\$ 100,000
- 11 (2) Election District No. 1..... 650,000
- 12 (3) Election District No. 2..... 650,000
- 13 (4) Election District No. 3..... 650,000
- 14 (5) Election District No. 4. Any unexpended

15 or unobligated funds as apportioned in this
16 paragraph (5) as of October 31, 2001, shall be
17 placed in an Infrastructure Projects, Roads,
18 and Other Economic and Social Projects and

1 Programs Trust Fund, which fund shall be
 2 maintained and invested by the Secretary of
 3 the Department of Finance and Administration,
 4 along with interest and other income therein,
 5 none of which shall be withdrawn before
 6 November 1, 2005.
