

A BILL FOR AN ACT

To further amend Public Law No. 10-143, as amended, by amending section 5 to change the allottee of funds for E.D. No. 1 in Chuuk State, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 5 of Public Law No. 10-143, as amended by
2 Public Law No. 12-___, is hereby further amended to read follows:

3 "Section 5. Allotment and management of funds and lapse date.

4 (1) All funds appropriated by this act shall be allotted,
5 managed, administered, and accounted for in accordance with
6 applicable law, including, but not limited to, the Financial
7 Management Act of 1979. The allottee of the funds
8 appropriated under section 1(1) of this act shall be the
9 ~~[Executive Director of the Mortlocks Development Commission]~~
10 Vice President of the Federated States of Micronesia, or his
11 designee. The allottee of the funds appropriated under
12 section 1(2) of this act shall be the Executive Director of
13 the Northern Namoneas Development Authority or his designee.
14 The allottee of the funds appropriated under section 1(3) of
15 this act shall be the Executive Director of the Chuuk State
16 Commission on Improvement Projects. ~~[If the Chuuk State~~
17 ~~Commission on Improvement Projects shall be abolished~~
18 ~~pursuant to Chuuk State law, the Chuuk State Commission on~~
19 ~~Improvement Projects shall be deemed to be, and shall be~~

1 ~~treated as, a continuing entity for the purposes of this~~
2 ~~measure.]~~ The allottee of the funds appropriated under
3 section 1(4) of this act shall be the Mayor of Polle. The
4 allottee of the funds appropriated under section 1(5) of this
5 act shall be the Northwest Islands Project Coordinator or his
6 designee. The allottee of the funds appropriated under
7 section 1(6) of this act shall be the Secretary of the
8 Department of Health, Education and Social Affairs of the
9 Federated States of Micronesia, or his designee. The
10 allottee of the funds appropriated under section 3 of this
11 act shall be the Governor of the State of Yap or the
12 Governor's designee. The allottee of the funds appropriated
13 under section 4 of this act shall be the Governor of the
14 State of Kosrae or the Governor's designee. The allottee of
15 all other funds appropriated by this act shall be the
16 President of the Federated States of Micronesia or the
17 President's designee. The allottees shall be responsible for
18 ensuring that these funds, or so much thereof as may be
19 necessary, are used solely for the purpose specified in this
20 act, and that no obligations are incurred in excess of the
21 sum appropriated.

22 (2) The authority of the allottees to obligate funds
23 appropriated by this act shall not lapse."

24 Section 2. This act shall become law upon approval by the
25 President of the Federated States of Micronesia or upon its becoming

1 law without such approval.
