

A BILL FOR AN ACT

To further amend Public Law No. 8-100, as amended, by amending section 1 to change the use of Chuuk Election District No. 1 funds, by amending section 6 to change the allottee of these funds, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 6 of Public Law No. 8-100, as amended by
2 Public Laws No. 8-121, 9-28, and 12-27, is hereby further amended
3 to read as follows:

4 "Section 6. Allotment and management of funds and
5 lapse date.

6 (1) All funds appropriated by this act shall be
7 allotted, managed, administered, and accounted for in
8 accordance with applicable law, including, but not
9 limited to, the Financial Management Act of 1979. The
10 allottee of the funds appropriated under subsections
11 (1), (6), (7), (8) and (9) of section 1 of this act
12 shall be the Secretary of Education. The allottee of
13 the funds appropriated under subsection (2) of section 1
14 of this act shall be the Executive Director of the
15 Mortlock Development Commission~~[Vice President of the~~
16 ~~Federated States of Micronesia]~~, or his designee. The
17 allottee of the funds appropriated under subsection (3)
18 of section 1 of this act shall be the Northern Namoneas

1 Development Authority. The allottee of the funds
2 appropriated under subsection (4) of section 1 of this
3 act shall be the Southern Namoneas Development
4 Authority. The allottee of the funds appropriated under
5 subsection (5) of section 1 of this act shall be the
6 Pattiw Development Authority. The allottee of the funds
7 appropriated under section 2 of this act shall be the
8 Governor of the State of Kosrae. The allottee of the
9 funds appropriated under subsections (1), (3) and (4) of
10 section 4 of this act shall be the Governor of the State
11 of Yap. The allottee of the funds appropriated under
12 subsection (2) of section 4 of this act shall be
13 President of the College of Micronesia-FSM. The
14 allottee of all other funds appropriated by this act
15 shall be the President of the Federated States of
16 Micronesia or the President's designee. The allottees
17 shall be responsible for ensuring that these funds, or
18 so much thereof as may be necessary, are used solely for
19 the purposes specified in this act, and that no
20 obligations are incurred in excess of the sum
21 appropriated.

22 (2) The authority of the allottees to obligate funds
23 appropriated by this act shall not lapse."

24 Section 2. This act shall become law upon approval by the
25 President of the Federated States of Micronesia or upon its

1 becoming law without such approval.
