

A BILL FOR AN ACT

To further amend Public Law No. 8-115, as amended, by amending section 1 thereof to reallocate certain funds appropriated to the Northwest Islands in the State of Chuuk, by amending section 5 thereof to change the allottee for such funds, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 1 of Public Law No. 8-115, as amended by  
2 Public Laws Nos. 10-2, 10-66, 11-51 and 12-32, is hereby further  
3 amended to read as follows:

4 "Section 1. The sum of \$500,000, or so much thereof as  
5 may be necessary, is hereby appropriated from the  
6 General Fund of the Federated States of Micronesia for  
7 the fiscal year ending September 30, 1995, to assist  
8 State-administered public health programs and for other  
9 public projects and programs in the State of Chuuk. The  
10 funds appropriated by this section shall be apportioned  
11 as follows:

5 Section 2. Section 5 of Public Law No. 8-115, as amended by  
6 Public Laws Nos. 10-37, 12-32 and 12-37, is hereby further amended  
7 to read as follows:

8 "Section 5. Allotment and management of funds and lapse  
9 date.

10 (1) All funds appropriated by this act shall be  
11 allotted, managed, administered, and accounted for in  
12 accordance with applicable law, including, but not  
13 limited to, the Financial Management Act of 1979. The  
14 allottee of the funds appropriated by subsections (1)  
15 and (6) of section 1 of this act shall be the Chuuk  
16 State Director of Health Services. The allottee of the  
17 funds appropriated by subsection (2) of section 1 of  
18 this act shall be the Chuuk State Commission on  
19 Improvement Projects. The allottee of the funds  
20 appropriated by subsection (3) of section 1 of this act  
21 shall be the Northern Namoneas Development Authority.  
22 The allottee of the funds appropriated by subsection (4)  
23 of section 1 of this act shall be the Executive Director  
24 of the Mortlock Development Commission, or his designee.  
25 The allottee of the funds appropriated by subsection (5)

1 of section 1 of this act shall be the [~~Pattiw~~  
2 ~~Development Authority~~] Northwest Islands Project  
3 Coordinator. The allottee of the funds appropriated by  
4 section 2 of this act shall be the Governor of Kosrae or  
5 his designee. The allottee of the funds appropriated by  
6 subsection (2) of section 3 of this act shall be the  
7 Pohnpei Transportation Authority. The allottee of all  
8 other funds appropriated by this act shall be the  
9 President of the Federated States of Micronesia or the  
10 President's designee, PROVIDED, that in the event of a  
11 designation by the President of another allottee of  
12 funds appropriated by subsection (1) of section 3 of  
13 this act, the President shall require that said designee  
14 provide a separate accounting to ensure that said funds  
15 are used solely for financing improvements to the water  
16 supply system in Sokehs Municipality. The allottees  
17 shall be responsible for ensuring that these funds, or  
18 so much thereof as may be necessary, are used solely for  
19 the purpose specified in this act, and that no  
20 obligations are incurred in excess of the sum  
21 appropriated.

22 (2) Notwithstanding Public Law No. 9-040, the  
23 authority of the allottees to obligate funds  
24 appropriated by this act shall not lapse."
