

A BILL FOR AN ACT

To further amend Public Law No. 11-59, as amended, by amending section 1 to change the use of certain funds for Kosrae State, by amending section 7 to change the allottee and lapse date for certain funds appropriated for Kosrae State, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 1 of Public Law No. 11-59, as amended by
2 Public Laws Nos. 11-69, 11-79 and 12-33, is hereby further amended
3 to read as follows:

4 "Section 1. The sum of \$350,000, or so much thereof as
5 may be necessary, is hereby appropriated from the
6 General Fund of the Federated States of Micronesia for
7 the fiscal year ending September 30, 2001, to provide
8 funds for infrastructure and other projects and programs
9 in the State of Kosrae. The funds appropriated under
10 this section shall be apportioned as follows:

1 Section 2. Section 7 of Public Law No. 11-59, as amended by
2 Public Laws Nos. 11-69, 11-79, 12-7 and 12-33, 12-46, 12-64, 12-71
3 and 13-2, is hereby further amended to read as follows:

4 "Section 7. Allotment and management of funds and lapse
5 date.

6 (1) All funds appropriated by this act shall be
7 allotted, managed, administered, and accounted for in
8 accordance with applicable law, including, but not
9 limited to, the Financial Management Act of 1979. The
10 allottee of the funds appropriated under subsection (1)
11 of section 1 of this act shall be the [~~Chairman of the~~
12 ~~Coordination Committee of the Kosrae State 2001 Summer~~
13 ~~Youth Conference~~] President of the Federated States of
14 Micronesia. The allottee of the funds appropriated
15 under subsections (2), [~~(4)~~] (3), [~~(5)~~] (4), [~~(10)~~] (9)
16 and [~~(11)~~] (10) of section 1 of this act shall be the
17 Secretary of the Department of Finance and
18 Administration, or his designee. The allottee of the
19 funds appropriated under subsection [~~(3)~~] (2) of section
20 1 and the funds appropriated under section 6 of this act
21 shall be the Governor of the State of Kosrae, or his
22 designee. The allottees of the funds appropriated under
23 subsections [~~(6)~~] (5) through [~~(9)~~] (8) of section 1 of
24 this act shall be the Mayors of the respective towns or
25 municipalities. The allottee of the funds appropriated

1 under sections 2 and 5 of this act shall be the
2 President of the Federated States of Micronesia, or his
3 designee. The allottee of the funds appropriated under
4 section 3 of this act shall be the Chuuk State
5 Commission on Improvement Projects, EXCEPT THAT the
6 allottee of the funds appropriated under subsection (6)
7 of section 3 of this act shall be the Northwest Project
8 Coordinator and PROVIDED THAT, for funds appropriated
9 under subsection (5) of section 3 of this act, the
10 allottee shall follow the procedures set forth in
11 subsection (3) of this section 7. The allottee of the
12 funds appropriated under subsections (1) through (13)
13 and subsection (15) of section 4 of this act shall be
14 the Governor of the State of Yap, or his designee. The
15 allottee of the funds appropriated under subsection (14)
16 of section 4 of this act shall be the Speaker of the
17 Congress of the Federated States of Micronesia, or his
18 designee. The allottees shall be responsible for
19 ensuring that the funds appropriated by this act, or so
20 much thereof as may be necessary, are used solely for
21 the purpose specified in this act, and that no
22 obligations are incurred in excess of the sum
23 appropriated.

24 (2) The authority of the allottees to obligate funds
25 appropriated by this act shall lapse as of September 30,

1 2005; EXCEPT THAT the authority of the allottee to
2 obligate funds appropriated under [~~subsection~~]
3 subsections (1) and [+10+] (9) of section 1 of this act
4 shall not lapse.

5 (3) Prior to any obligation or disbursement of funds
6 appropriated under subsection (5) of section 3 of this
7 act, the allottee shall, by written notice to the mayor
8 of each municipality in Election District No. 4 of Chuuk
9 State, inform each municipality of the amount of funds
10 available for allotment in Election District No. 4 and
11 invite requests for project funding from each
12 municipality. Not less than thirty (30) days nor more
13 than sixty (60) days after delivering such notice, the
14 allottee shall convene and chair a panel consisting of
15 all the Mayors of Election District No. 4 or their
16 designees, who shall review the requests for project
17 funding and determine, by majority vote, which
18 project(s) shall be recommended to the allottee for
19 funding. The allottee shall not have a vote except in
20 the event of a tie. In the event of a tie, the
21 Executive Director of the allottee, or his designee,
22 shall cast the deciding vote. The allottee's designee
23 shall not be a resident or former resident of Election
24 District No. 4. Subject to relevant law and
25 regulations, the allottee shall follow the
