
A BILL FOR AN ACT

To further amend Public Law No. 10-120, as amended, by amending section 1 thereof to specify the use of the funds for Election District 3, to change the allottee of such funds, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Amendment. Section 1 of Public Law No. 10-120,
2 as amended by Public Laws Nos. 10-122, 10-144, 11-8, 11-20, 11-32,
3 12-6, 12-20, 12-68, 13-11 and is hereby further amended to read as
4 follows:

5 "Section 1. The sum of \$5,000,000, or so much thereof
6 as may be necessary, is hereby appropriated from the
7 General Fund of the Federated States of Micronesia for
8 the fiscal year ending September 30, 1999, for the
9 purpose of funding infrastructure and other projects and
10 programs in the State of Chuuk. The funds appropriated
11 under this section shall be apportioned as follows:

- 12 (1) Regional transportation projects
13 (which shall be deemed to come from capital
14 account funds available under section 211
15 of the Compact of Free Association)
- 16 (a) Ta airport paving and related
17 structures and equipment\$ 200,000
- 18 (b) Houk airport paving, including

13 Section 2. Amendment. Section 6 of Public Laws Nos. 10-120
 14 as amended by Public Laws Nos. 10-122, 11-8, 11-10, 11-20, 11-32,
 15 11-64, 11-75, 12-20, 12-47, 12-68, 13-11 and 13-31, is hereby
 16 further amended to read as follows:

17 "Section 6. Allotment and management of funds and lapse
 18 date.

19 (1) All funds appropriated by this act shall be
 20 allotted, managed, administered, and accounted for in
 21 accordance with applicable law, including, but not
 22 limited to, the Financial Management Act of 1979. The
 23 allottee of the funds appropriated under section 1(3)(e)
 24 of this act shall be the Governor of the State of Chuuk
 25 or his designee. The allottee of the funds appropriated

1 under section 1(2) of this act shall be the Speaker of
2 the Congress of the Federated States of Micronesia. The
3 allottee of the funds appropriated under section 1(3)(a)
4 of this act shall be the Director of the Department of
5 Health Services. The allottee of the funds appropriated
6 under section 1(3)(c) of this act shall be the Assistant
7 Director, Land Grant Program, Cooperative Extension
8 Services, Chuuk State. The allottee of the funds
9 appropriated under section 1(3)(d) of this act shall be
10 the Executive Director of the Chuuk Recreation Office.
11 The allottee of the funds appropriated under section
12 1(3)(f) of this act shall be the Secretary of the
13 Department of Health, Education and Social Affairs of
14 the Federated States of Micronesia, or his designee.
15 The allottee of the funds appropriated under section
16 1(3)(g) of this act shall be the Chuuk State Commission
17 on Improvement Projects. The allottee of the funds
18 appropriated under sections 1(5) and 1(3)(b) of this act
19 shall be the Executive Director of the Northern Namoneas
20 Development Authority, or if the Northern Namoneas
21 Development Authority shall be abolished, the Northern
22 Namoneas Project Coordinator or his designee. The
23 allottee of the funds appropriated under sections 1(4)
24 [~~and 1(6)(b)~~] of this act shall be the Executive
25 Director of the Chuuk State Commission on Improvement

1 Projects. The allottee of the funds under section 1(6)
2 of this act shall be the Southern Namoneas Development
3 Authority. At the beginning of each quarter, the
4 Secretary of the Department of Finance and
5 Administration, or his designee, shall provide a status
6 report to the member of Congress representing Chuuk
7 Election District No. 3 on the Educational and Health
8 Trust Fund created pursuant to section 1(6)(b) of this
9 act. Said report shall describe the investment status
10 of the fund and changes in fund balances since the
11 previous report, including nominal and real rates of
12 return on investments. [~~The allottee of the funds~~
13 ~~appropriated under section 1(6)(a) of this act shall be~~
14 ~~the Chuuk State Commission on Improvement Projects.]
15 The allottee of the funds appropriated under section
16 1(7) of this act shall be the Mayor of Polle. The
17 allottee of the funds appropriated under section 1(8) of
18 this act shall be the Chuuk State Commission on
19 Improvement Projects. The allottee of the funds
20 appropriated under section 2(1) of this act shall be the
21 respective mayor of each municipality listed therein.
22 The allottee of the funds appropriated under sections
23 2(2) through 2(8) of this act shall be the Governor of
24 the State of Kosrae. The allottee of the funds
25 appropriated under section 2(9) of this act shall be the~~

1 President of the Federated States of Micronesia, or the
2 President's designee. The allottee of the funds
3 appropriated under section 3(1)(a) of this act shall be
4 the Mayor of Kolonia Town, and said allottee shall
5 obligate no more than \$3,000 of such funds for
6 administrative costs. The allottee of the funds
7 appropriated under sections 4(1) through 4(7), 4(9)
8 through 4(18), and 4(24) of this act shall be the
9 Governor of the State of Yap. The allottee of the funds
10 appropriated under section 4(8) of this act shall be the
11 Speaker of the Congress of the Federated States of
12 Micronesia. The allottee of the funds appropriated
13 under section 4(23) of this act shall be the Secretary
14 of the Department of Health, Education and Social
15 Affairs. The allottee of all other funds appropriated
16 by this act shall be the President of the Federated
17 States of Micronesia or the President's designee. In
18 the event that the President designates the Vice
19 President as allottee, the Vice President may designate
20 a suballottee. The allottees shall be responsible for
21 ensuring that these funds, or so much thereof as may be
22 necessary, are used solely for the purpose specified in
23 this act, and that no obligations are incurred in excess
24 of the sum appropriated. The allottee of the funds
25 appropriated under section 3(2) of this act shall

1 obligate no more than ten percent of such funds for
2 administrative costs.

3 (2) The authority of the allottees to obligate funds
4 appropriated by this act shall not lapse."

5 Section 3. This act shall become law upon approval by the
6 President of the Federated States of Micronesia or upon its
7 becoming law without such approval.
