

A BILL FOR AN ACT

To further amend Public Law No. 8-19, as amended, by amending section 3 thereof to change the allottee of certain funds, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 3 of Public Law No. 8-19, as
2 amended by Public Laws Nos. 8-72, 8-107, 9-016 and 9-044,
3 is hereby further amended to read as follows:
4 "Section 3. All funds appropriated by this act
5 shall be allotted, managed, administered, and
6 accounted for in accordance with applicable law,
7 including, but not limited to, the Financial
8 Management Act of 1979. The allottee of the funds
9 appropriated under subsection (1)(a) of section 2
10 of this act shall be the PWP Development Authority.
11 ~~[The allottee of the funds appropriated under~~
12 ~~subsections (1)(b)(i) through (1)(b)(v) of section~~
13 ~~2 of this act shall be the Southern Namoneas~~
14 ~~Development Authority. The allottee of the funds~~

1 Southern Namoneas Mayors Conference. The allottee
2 of the funds appropriated under subsection (1)(c)
3 of section 2 of this act shall be the Lower
4 Mortlocks Development Authority. The allottee of
5 the funds appropriated under subsection (1)(d) of
6 section 2 of this act shall be the Northern
7 Namoneas Development Authority. The allottee of
8 the funds appropriated under subsection (1)(e) of
9 section 2 of this act shall be the Pattiw
10 Development Authority. The allottee of the funds
11 appropriated under subsection (1)(f) of section 2
12 of this act shall be the Saramen Chuuk Academy
13 Board of Directors. The allottee of all other
14 funds appropriated under section 2 of this act
15 shall be the President or the President's designee,
16 except that for Pohnpei State funds to be disbursed
17 to Madolenihmw and Kitti, the allottees shall be
18 the respective chief magistrates; PROVIDED, the
19 allottee of the funds appropriated under subsection
20 (3) of section 2 of this act shall be the Governor
21 of the State of Yap. The allottees shall be
22 responsible for ensuring that these funds, or so
23 much thereof as may be necessary, are used solely
24 for the purpose specified in this act, and that no
25 obligations are incurred in excess of the sum

1 appropriated. The authority of the allottees to
2 obligate funds appropriated by this act shall not
3 lapse."

4 Section 2. This act shall become law upon approval by the
5 President of the Federated States of Micronesia or upon its
6 becoming law without such approval.
