

A BILL FOR AN ACT

To further amend Public Law No. 6-49, as amended, by further amending section 1, thereof to deposit certain funds appropriated therein into the fund entitled "Public Projects for Chuuk Election District No. 3" within the General Fund of the Federated States of Micronesia, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 1 of Public Law No. 6-49, as amended by
2 Public Laws Nos. 6-55, 6-96, 7-57 and 8-109, is hereby further
3 amended to read as follows:

4 "Section 1. Statewide public projects. The sum of
5 \$200,000, or so much thereof as may be necessary, is
6 hereby appropriated from the General Fund of the
7 Federated States of Micronesia for the fiscal year
8 ending September 30, 1990, for the purpose of funding
9 certain statewide public projects in Chuuk State. The
10 sum appropriated by this section shall be apportioned as
