

A BILL FOR AN ACT

To reappropriate the sum of \$634,539 or so much thereof as is necessary, from lapsed fund as of June 30, 2006 in the General Fund of the Federated States of Micronesia for the States of Kosrae and Chuuk, for the purpose of funding public projects and social programs, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. The sum of \$450,552 or so much thereof as may be  
2 necessary that lapsed as of June 30, 2006 as required by Public  
3 Law No. 14-35 from Public Law Nos. 7-107, 8-115, 8-19, 9-095, 9-  
4 52, 10-120, 10-143, 11-36 and 11-59 for the State of Kosrae, is  
5 hereby reappropriated from the General Fund of the Federated  
6 States of Micronesia for the fiscal year ending September 30,  
7 2006, for the purpose of funding infrastructure projects,  
8 economic development projects and social programs in the State of  
9 Kosrae.

10 Section 2. The sum of \$90,971 or so much thereof as may be  
11 necessary that lapsed as of June 30, 2006 as required by Public  
12 Law No. 14-35 from Public Law Nos. 7-35, 8-9, 8-75, 8-100, 8-115,  
13 9-052, 10-120, 10-143, 11-36 and 12-36 for Chuuk State At Large,  
14 is hereby reappropriated from the General Fund of the Federated  
15 States of Micronesia for the fiscal year ending September 30,  
16 2006, for the purpose of funding projects and social programs as  
17 follows:

- 19 (i) Youth & Gender Groups Activities.... \$15,000

6 Section 3. The sum of \$10,046 or so much thereof as may be  
7 necessary that lapsed as of June 30, 2006 as required by Public  
8 Law No. 14-35 from Public Law No. 12-36 for Election District No.  
9 2 in the State of Chuuk, is hereby reappropriated from the  
10 General Fund of the Federated States of Micronesia for the fiscal  
11 year ending September 30, 2006, for the purpose of funding  
12 projects and social programs as follows:

13	1. Leadership travel for Election	
14	District No. 2.....\$	10,046

15 Section 4. The sum of \$82,970 or so much thereof as may be  
16 necessary that lapsed as of June 30, 2006 as required by Public  
17 Law No. 14-35 from Public Law Nos. 8-19, 8-100, 9-052 and 9-095  
18 for Election District No. 4 in the State of Chuuk, is hereby  
19 reappropriated from the General Fund of the Federated States of  
20 Micronesia for the fiscal year ending September 30, 2006, for the  
21 purpose of funding projects and social programs in the State of  
22 Chuuk as follows:

23	1) Election District No. 4	
24	(i) West Fason Housing Project.....\$	20,000
25	(ii) Wonei Fishing Program.....	20,000

1	(iii) Delegation office operation.....	30,000

4 Section 5. All funds appropriated by this act shall be  
5 allotted, managed, administered, and accounted for in accordance  
6 with applicable law, including, but not limited to, the Financial  
7 Management Act of 1979. The allottee of the funds appropriated  
8 in Section 1 of this Act shall be the President of the Federated  
9 States of Micronesia or the President's designee. The allottee  
10 of the funds appropriated in Sections 2, 3 and 4 of this Act  
11 shall be the Chuuk State Commission on Improvement Project. The  
12 allottee shall be responsible for ensuring that these funds, or  
13 so much thereof as may be necessary, are used solely for the  
14 purpose specified in this act, and that no obligations are  
15 incurred in excess of the sum appropriated. The authority of the  
16 allottee to obligate funds appropriated by this act shall lapse  
17 as of September 30, 2008.

18 Section 6. This act shall become law upon approval by the  
19 President of the Federated States of Micronesia or upon its  
20 becoming law without such approval.
