

A BILL FOR AN ACT

To further amend Public Law No. 14-107, as amended, by amending Section 2 thereof, to change the use of certain funds previously appropriated for Election District No. 1, Pohnpei State, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 2 of Public Law No. 14-107, as amended by
2 Public Law No. 15-03 is hereby further amended to read as follows:

3 "Section 2. The sum of \$421,110, is hereby appropriated
4 from the General Fund of the Federated States of Micronesia for
5 the fiscal year ending September 30, 2007 for the purpose of
6 funding public projects and social programs in the States of
7 Chuuk, Kosrae, Pohnpei and Yap. The funds appropriated under
8 section 1 of this act shall be apportioned as follow:

9 (1) State of Yap.....\$ 121,872

10 (a) Land acquisition for Outer Islanders,

11 PROVIDED THAT the title of the land purchased on Yap proper
12 and responsibility for administration of such land to be held
13 in Trust by the Council of Tamol of the Outer Islands for the
