

AN ACT

To further amend Public Law No. 15-25 by amending Section 1 thereof, to change the use of certain funds previously appropriated therein, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 1 of Public Law No. 15-25, is hereby  
2 amended to read as follows:

3 "Section 1. The sum of \$366,255 realized from the 20%  
4 restricted funds previously allocated for Health and  
5 Education in Chuuk State and now lapsed into the general  
6 fund, is hereby appropriated from the General Fund of  
7 the Federated States of Micronesia for the fiscal year  
8 ending September 30, 2008 for the purpose of funding  
9 Public Projects in Chuuk State, and shall be apportioned  
10 as follow:

11	(1) Chuuk Public Utility Corporation ....\$	150,000
12	(2) Chuuk State Health Care Plan .....	123,875
13	(3) Health and Education related	
14	projects and programs .....	92,380
15	(a) Office Rental .....	20,000
16	(b) Road Pavement .....	22,000
17	(c) Medicine and medical	
18	supplies for Chuuk .....	9,000
19	(d) Chuuk Nursing Association .....	6,000
20	(e) School furniture & supplies ....\$	10,000

1	(f) POL & Freight cost .....	10,000
2	(g) Students' land transportation ...	15,380"

3       Section 2. Allotment and management of funds and lapse date.

4 All funds appropriated by this act shall be allotted, managed,  
5 administered and accounted for in accordance with applicable laws,  
6 including, but not limited to, the Financial Management Act of  
7 1979. The allottee shall be responsible for ensuring that these  
8 funds, or so much thereof as may be necessary, are used solely for  
9 the purpose specified in this act, and that no obligations are  
10 incurred in excess of the sum appropriated. The allottee of the  
11 funds appropriated under subsections 1 and 2 of Section 1 of this  
12 act shall be the President of the Federated States of Micronesia.  
13 The allottee of the funds appropriated under subsection 3 of  
14 Section 1 of this act shall be the Chuuk State Commission  
15 Improvement Project. The authority of the allottee to obligate  
16 funds appropriated by this act shall lapse on September 30, 2008."

25       Section 3. This act shall become law upon approval by the  
26 President of the Federated States of Micronesia or upon its

1 becoming law without such approval.
