

A BILL FOR AN ACT

To appropriate from the General Fund of the Federated States of Micronesia, a sum of \$3.5 million for the purpose of funding public projects and social programs in the four States, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. The sum of \$3.5 million, or so much thereof is
2 hereby appropriated from the General Fund of the Federated States
3 of Micronesia for the fiscal year ending September 30, 2010 for
4 projects and programs in each state of the Federated States of
5 Micronesia. The fund shall be apportioned on the basis of
6 \$250,000 per member of Congress as follows:

17 Section 2. Allotment and management of funds and lapse date.

18 All funds appropriated by this act shall be allotted, managed,
 19 administered and accounted for in accordance with applicable laws,
 20 including, but not limited to the Financial Management Acts of
 21 each of the State, the Financial Management Act of 1979 and the
 22 amended Compact of Free Association between the United States
 23 Government and the Government of the Federated States of
 24 Micronesia and its related agreements. The allottee shall be
 25 responsible for ensuring that these funds, or so much thereof as

1 may be necessary, are used solely for the purpose specified in
2 this act, and that no obligations are incurred in excess of the
3 sum appropriated. The allottee of the funds appropriated under
4 subsections (4) (a), (c), (d), (e) and (f) of section 1 of this act
5 shall be the Chuuk State Commission on Improvement Project. The
6 allottee of the appropriated funds under subsection (4) (b) of
7 section 1 of this act shall be the Mortlocks Commission. [~~The~~
8 ~~allottee of funds appropriated under subsection (4) (e) of section~~
9 ~~1 of this act shall be Mayor of Pelle]~~. The allottee of funds
10 appropriated under subsections (1) (a) (b), (2) (a) (b), 3(a) (b) (c)
11 and (d) of this act shall be the President of the Federated States
12 of Micronesia. The funds appropriated by this act shall remain
13 available until fully expended.

14 Section 3. This act shall become law upon approval by the
15 President of the Federated States of Micronesia or upon its
16 becoming law without such approval.
