

A BILL FOR AN ACT

To appropriate the sum of \$1,050,000 from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 2011, for the purpose of funding public projects and social programs in each of the four states, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. The sum of \$1,050,000, or so much thereof as  
2 may be necessary, is hereby appropriated from the General Fund  
3 of the Federated States of Micronesia for the fiscal year  
4 ending September 30, 2011, for the purpose of funding public  
5 projects and social programs in each of the four states.

6 Section 2. Of the sum of \$1,050,000 appropriated by this  
7 act, \$255,000 is apportioned for Kosrae State for public projects  
8 and social programs.

9 (1) State of Kosrae ..... \$ 150,000

10 Section 3. Of the sum of \$1,050,000 appropriated by  
11 this act, \$150,000 is apportioned for Yap State for  
12 public projects and social programs.

13 (1) State of Yap..... \$ 150,000

14 Section 4. Of the sum of \$1,050,000 appropriated by this  
15 act, \$300,000 is apportioned for Pohnpei State for public  
16 projects and social programs.

17 State of Pohnpei..... \$ 300,000

18 (1) Pohnpei at Large..... \$ 75,000

19 (2) Election District No. 1..... \$ 75,000

3	Section 5. Of the sum of \$1,005,000 appropriated by this	
4	act, \$450,000 is apportioned for Chuuk State for public	
5	projects and social programs.

13 Section 6. Allotment and management of funds and lapse  
14 date. All funds appropriated by this act shall be allotted,  
15 managed, administered and accounted for in accordance with  
16 applicable law, including, but not limited to, the Financial  
17 Management Act of 1979. The allottee shall be responsible for  
18 ensuring that these funds, or so much thereof as may be  
19 necessary, are used solely for the purpose specified in this  
20 act, and that no obligations are incurred in excess of the sum  
21 appropriated. The allottee of funds appropriated under  
22 sections 2 and 4 of this act shall be the President of the  
23 Federated States of Micronesia or his designee. The allottee  
24 of funds appropriated under section 3 of this act shall be the  
25 Governor of Yap State. The allottee of funds appropriated

1 under subsections 5(1)(2)(4)(5) and (6) shall be the Chuuk  
2 State Commission on Improvement Project (CSCIP). The allottee  
3 of funds appropriated under subsection 5(3) of this act shall  
4 be the Executive Director of the Northern Namoneas Social and  
5 Economic Development Authority. The funds appropriated by this  
6 act shall remain available until fully expended.

7 Section 7. This act shall become law upon approval by the  
8 President of the Federated States of Micronesia or upon its  
9 becoming law without such approval.
