PUBLIC LAW NO. 16-71

AN ACT

To amend Public Law No. 16-62 by amending sections 2, 4 and 6 thereof, to modify the use and allottees of funds previously appropriated therein to fund public projects and social programs in the States of Kosrae and Pohnpei, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 2 of Public Law No. 16-62 is hereby
2 amended to read as follows:

3 "Section 2. Of the sum of \$1,050,000 appropriated by
4 this act, \$255,000 is apportioned for Kosrae State for
5 public projects and social programs.

23 Section 3. Section 6 of Public Law No. 16-62 is hereby
24 amended to read as follows:

25 "Section 6. Allotment and management of funds and lapse

1 date. All funds appropriated by this act shall be
2 allotted, managed, administered and accounted for in
3 accordance with applicable law, including, but not
4 limited to, the Financial Management Act of 1979. The
5 allottee shall be responsible for ensuring that these
6 funds, or so much thereof as may be necessary, are used
7 solely for the purpose specified in this act, and that
8 no obligations are incurred in excess of the sum
9 appropriated. The allottee of funds appropriated under
10 sections 2 and 4 of this act shall be the President of
11 the Federated States of Micronesia or his designee,
12 PROVIDED THAT the allottee of funds appropriated under
13 subsection 4(1)(c) of this act shall be the Pohnpei
14 Transportation Authority. The allottee of funds
15 appropriated under section 3 of this act shall be the
16 Governor of Yap State. The allottee of funds
17 appropriated under subsections 5(1)(2)(4)(5) and (6)
18 shall be the Chuuk State Commission on Improvement
19 Project (CSCIP). The allottee of funds appropriated
20 under subsection 5(3) of this act shall be the Executive
21 Director of the Northern Namoneas Social and Economic
22 Development Authority. The funds appropriated by this
23 act shall remain available until fully expended."

25 Section 4. This act shall become law upon approval by the

1 President of the Federated States of Micronesia or upon its
2 becoming law without such approval.
