

A BILL FOR AN ACT

To further amend sections 2 and 3 of Public Law No. 14-107, as amended by Public Laws Nos. 15-03, 15-20, 17-15, and 17-43, to change the use and allottee of certain funds previously appropriated for Yap State, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 2 of Public Law No. 14-107, as amended
2 by Public Laws Nos. 15-03, 15-20, 17-15, and 17-43 is hereby
3 further amended to read as follows:

4 "Section 2. The sum of \$421,100, is hereby
5 appropriated from the General Fund of the Federated
6 States of Micronesia for the fiscal year ending
7 September 30, 2007 for the purpose of funding public
8 projects and social programs in the States of Chuuk,
9 Kosrae, Pohnpei and Yap. The funds appropriated under
10 section 1 of this act shall be apportioned as follows:

11 (1) State of Yap.....\$ 121,872

12 (a) Land acquisition for outer islanders,
13 PROVIDED THAT the title of the land purchased on
14 Yap proper and responsibility for administration
15 of such land to be held in Trust by the Council of
16 Tamol of the Outer Islands for the benefit of the
17 people of the outer islands of Yap . [~~100,000~~] 50,000

25	Section 2. Section 3 of Public Law No. 14-107, as	

1 amended by Public Law No. 15-03, is hereby further amended to
2 read as follows:

3 All funds appropriated by this act shall be allotted,
4 managed, administered, and accounted for in accordance
5 with applicable law, including, but not limited to, the
6 Financial Management Act of 1979. The allottee of the
7 funds appropriated in subsection 1 (a) and (c) of
8 Section 1 of this Act shall be the Governor of Yap
9 State. The allottee of funds appropriated in
10 subsection 1 (b) of section 1 of this Act shall be the
11 President of the College of Micronesia - FSM. The
12 allottee of the funds appropriated in subsection 2 of
13 Section 1 of this Act shall be the Chuuk State
14 Commission on Improvement Project (CSCIP). The
15 allottee of funds appropriated in subsections 3 and 4
16 of Section 1 of this Act shall be the President of the
17 Federated States of Micronesia or his designee. The
18 allottee shall be responsible for ensuring that these
19 funds, or so much thereof as may be necessary, are used
20 solely for the purpose specified in this act, and that
21 no obligations are incurred in excess of the sum
22 appropriated. The authority of the allottee to
23 obligate funds appropriated by this act shall not
24 lapse.

25 Section 3. This act shall become law upon approval by the

1 President of the Federated States of Micronesia or upon its
2 becoming law without such approval.
