A BILL FOR AN ACT

To appropriate the sum of \$5,697,383 from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 2013, for the purpose of paying the amount owed by the State Governments to FEMA and to fund public projects and social programs in the States of Yap, Kosrae, Pohnpei and Chuuk, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

- 1 Section 1. The sum of \$5,697,383, or so much thereof as may
- 2 be necessary, is hereby appropriated from the General Fund of the
- 3 Federated States of Micronesia for the fiscal year ending
- 4 September 30, 2013, for the purpose of paying the amount owed by
- 5 the State Governments to FEMA and to fund public projects and
- 6 social programs in the States of Yap, Kosrae, Pohnpei and Chuuk.

- 10 act, \$284,210 is apportioned to pay the amount owed by the State
- 11 of Yap to FEMA and \$600,000 is apportioned for public projects and
- 12 social programs in the State of Yap.

- 15 Section 3. Of the sum of \$5,697,383 appropriated by this

- 18 projects and social programs in the State of Kosrae.

1 Section 6. Allotment and management of funds and lapse date. All funds appropriated by this act shall be allotted, 2 managed, administered and accounted for in accordance with applicable laws, including, but not limited to, the Financial Management Act of 1979. The allottee shall be responsible for ensuring that these funds, or so much thereof as may be necessary, are used solely for the purpose specified in this 7 act, and that no obligations are incurred in excess of the sum 9 appropriated. The allottee of the funds appropriated under 10 section 2 of this act shall be the Governor of Yap State. allottee of funds appropriated under sections 3 and 4 of this 11 12 act shall be the President of the Federated States of Micronesia or his designee, EXCEPT THAT the allottee of funds 13 appropriated under subsection 1 of section 3 of this act shall 14 be the Governor of Kosrae State and the allottee of funds 15 appropriated under subsection 1 of section 4 of this act shall 16 17 be the Governor of Pohnpei State. The allottee of funds 18 appropriated under subsections 5(1), 5(2)(a) and 5(2)(f) of this act shall be the Governor of Chuuk State or his designee. 19 20 The allottee of funds appropriated under subsection 5(b) of 21 section 5 of this act shall be the Mortlock Islands Development Authority. The allottee of funds appropriated under subsection 22 23 5(c) of section 5 of this act shall be the Executive Director of the Northern Namoneas Social and Economic Development 24 Authority or his designee. The allottee of funds appropriated
