

A BILL FOR AN ACT

To appropriate the sum of \$3,000,000 from the Foreign Assistance Fund of the Federated States of Micronesia for the fiscal year ending September 30, 2011, for the purpose of funding public projects and social programs in each of the four states, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. The sum of \$3,000,000, or so much thereof as
2 may be necessary and available from the specific source
3 identified by this act, is hereby appropriated from the Foreign
4 Assistance Fund of the Federated States of Micronesia for the
5 fiscal year ending September 30, 2011, for the purpose of
6 funding public projects and social programs in each of the four
7 states of the Federated States of Micronesia. The funds
8 appropriated herein are deemed sourced from funds granted to
9 the Federated States of Micronesia during Presidential
10 inauguration activities of 2011 from the People’s Republic of
11 China. In the event the amount received from the People’s
12 Republic of China is less than \$3,000,000, the amount received
13 shall fund this act and shall be apportioned among the four
14 states according to the formula of apportionment followed by
15 this act.

16 Section 2. Of the sum of \$3,000,000 appropriated by this
17 act, \$500,000 is apportioned for Kosrae State for public projects
18 and social programs.

2 Section 6. Allotment and management of funds and lapse
3 date. All funds appropriated by this act shall be allotted,
4 managed, administered and accounted for in accordance with
5 applicable law, including, but not limited to, the Financial
6 Management Act of 1979. The allottee shall be responsible for
7 ensuring that these funds, or so much thereof as may be
8 necessary, are used solely for the purpose specified in this
9 act, and that no obligations are incurred in excess of the sum
10 appropriated. The allottee of funds appropriated under
11 sections 2 and 4 of this act shall be the President of the
12 Federated States of Micronesia or his designee. The allottee
13 of funds appropriated under section 3 of this act shall be the
14 Governor of Yap State. The allottee of funds appropriated
15 under subsections 5(1)(2)(4)(5) and (6) shall be the Chuuk
16 State Commission on Improvement Project (CSCIP). The allottee
17 of funds appropriated under subsection 5(3) of this act shall
18 be the Executive Director of the Northern Namoneas Social and
19 Economic Development Authority. The funds appropriated by this
20 act shall remain available until fully expended.

21 Section 7. This act shall become law upon approval by the
22 President of the Federated States of Micronesia or upon its
23 becoming law without such approval.
