

A BILL FOR AN ACT

To appropriate the sum of \$2,100,000 from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 2012, for the purpose of funding public projects and social programs in the States of Yap, Kosrae, Pohnpei and Chuuk, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. The sum of \$2,100,000, or so much thereof as  
2 may be necessary, is hereby appropriated from the General Fund  
3 of the Federated States of Micronesia for the fiscal year  
4 ending September 30, 2012, for the purpose of funding public  
5 projects and social programs in the States of Yap, Kosrae,  
6 Pohnpei and Chuuk. The funds appropriated under this section  
7 shall be apportioned as follows:

8 Section 2. Of the sum of \$2,100,000 appropriated by this  
9 act, \$300,000 is apportioned for Yap State for public projects  
10 and social programs.

1 Section 4. Of the sum of \$2,100,000 appropriated by this  
2 act, \$600,000 is apportioned for Pohnpei State for public  
3 projects and social programs.

9 Section 5. Of the sum of \$2,100,000 appropriated by this  
10 act, \$900,000 is apportioned for Chuuk State for public  
11 projects and social programs.

19 Section 6. Allotment and management of funds and lapse  
20 date. All funds appropriated by this act shall be allotted,  
21 managed, administered and accounted for in accordance with  
22 applicable laws, including, but not limited to, the Financial  
23 Management Act of 1979. The allottee shall be responsible for  
24 ensuring that these funds, or so much thereof as may be  
25 necessary, are used solely for the purpose specified in this

1 act, and that no obligations are incurred in excess of the sum  
2 appropriated. The allottee of the funds appropriated under  
3 sections 2 through 5 of this act shall be the President of the  
4 Federated States of Micronesia. The authority of the allottee  
5 to obligate funds appropriated by this act shall lapse on  
6 September 30, 2014.

7 Section 7. This act shall become law upon approval by the  
8 President of the Federated States of Micronesia or upon its  
9 becoming law without such approval.
