

A BILL FOR AN ACT

To amend Public Law No. 18-42, by amending section 1 thereof, to change the use of certain funds previously appropriated therein, to fund the airport terminal facilities improvement in the States of Kosrae, Chuuk, Yap and Pohnpei, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 1 of Public Law No. 18-42 is hereby  
2 amended to read as follows:

3 "Section 1. The sum of \$400,000 is hereby  
4 appropriated from the General Fund of the Federated  
5 States of Micronesia for the fiscal year ending  
6 September 30, 2014. The funds appropriated under  
7 this section shall be used to fund the improvement of  
8 airport terminal facilities and the upgrade of  
9 equipment of the Aircraft Rescue and Fire Fighting  
10 (ARFF) buildings in the States of Kosrae [~~and~~],  
11 Chuuk, Pohnpei and Yap:

12 (1) Airport Terminal Facility Improvement in  
13 Chuuk.....\$125,000

14 (2) Airport Terminal Facility Improvement in Kosrae  
15 and upgrade or replacement of ARFF switchgear or  
16 Transformer..... 100,000

17 (3) Airport Terminal Facility (passenger processing  
18 areas) Improvement in Yap..... 100,000

19 (4) Airport Terminal Facility Improvement in

1 Pohnpei..... \$ 75,000"

2 Section 2. Allotment and management of funds and lapse  
3 date. All funds appropriated by this act shall be allotted,  
4 managed, administered and accounted for in accordance with  
5 applicable laws, including, but not limited to, the Financial  
6 Management Act of 1979. The allottee shall be responsible for  
7 ensuring that these funds, or so much thereof as may be  
8 necessary, are used solely for the purpose specified in this  
9 act, and that no obligations are incurred in excess of the sum  
10 appropriated. The allottee of the funds appropriated under  
11 this act shall be the respective Governor of each of the  
12 States, except the allottee for Pohnpei State's share of  
13 Airport funds shall be the Pohnpei Port Authority and the  
14 allottee of Kosrae State's share of fund shall be the Kosrae  
15 Port Authority. The authority of the allottee to obligate  
16 funds appropriated by this act shall lapse on September 30,  
17 2015.

18 Section 3. This act shall become law upon approval by the  
19 President of the Federated States of Micronesia or upon its  
20 becoming law without such approval.
