

A BILL FOR AN ACT

To appropriate the sum of \$2,800,000 from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 2014, for the purpose of funding public projects and social programs in the States of Yap, Kosrae, Pohnpei and Chuuk, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. The sum of \$2,800,000, or so much thereof as may
2 be necessary, is hereby appropriated from the General Fund of the
3 Federated States of Micronesia for the fiscal year ending
4 September 30, 2014, for the purpose funding public projects and
5 social programs in the States of Yap, Kosrae, Pohnpei and Chuuk.
6 The funds appropriated under this section shall be apportioned as
7 follows:

8 Section 2. Of the sum of \$2,800,000 appropriated by this
9 act, \$400,000 is apportioned for public projects and social
10 programs in the State of Yap.

11 State of Yap..... \$ 400,000

12 Section 3. Of the sum of \$2,800,000 appropriated by this
13 act, \$400,000 is apportioned for public projects and social
14 programs in the State of Kosrae.

15 State of Kosrae..... \$ 400,000

16 Section 4. Of the sum of \$2,800,000 appropriated by this
17 act, \$800,000 is apportioned for public projects and social
18 programs in the State of Pohnpei.

5 Section 5. Of the sum of \$2,800,000 appropriated by
 6 this act, \$1,200,000 is apportioned for public projects
 7 and social programs in the State of Chuuk.

15 Section 6. Allotment and management of funds and lapse date.
 16 All funds appropriated by this act shall be allotted, managed,
 17 administered and accounted for in accordance with applicable laws,
 18 including, but not limited to, the Financial Management Act of
 19 1979. The allottee shall be responsible for ensuring that these
 20 funds, or so much thereof as may be necessary, are used solely for
 21 the purpose specified in this act, and that no obligations are
 22 incurred in excess of the sum appropriated. The allottee of the
 23 funds appropriated under section 2 of this act shall be the
 24 Governor of Yap State. The allottee of funds appropriated under
 25 sections 3 and 4 of this act shall be the President of the
