

A BILL FOR AN ACT

To amend sections 1121 and 1124 of title 11 of the Code of the Federated States of Micronesia, as amended, by adding new designated substances to sections as required under the 1971 Convention on Psychotropic Substances; and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 1121 of title 11 of the Code of the
2 Federated States of Micronesia, as amended, is hereby amended to
3 read as follows:

4 "Section 1121 Schedule II - Designated. The controlled
5 substances listed in this section are included in
6 schedule II:

7 (1) any of the following substances except those
8 narcotic drugs listed in other schedules, whether
9 produced directly or indirectly by extraction from
10 substances of vegetable origin, or independently by
11 means of chemical synthesis, or by combination of
12 extraction and chemical synthesis:

13 (a) opium and opiate, and any salt, compound,
14 derivative, or preparation of opium or opiate;

15 (b) any salt, compound, isomers, derivative, or
16 preparation thereof which is chemically equivalent or
17 identical with any of the substances referred to in
18 paragraph (a) of this subsection, but not including the
19 isoquinoline alkaloids of opium;

20 (c) opium poppy and poppy straw;

1 (d) coca leaves and any salt, compound,
2 derivative, or preparation of coca leaves, and any salt,
3 compound, derivative, or preparation thereof which is
4 chemically equivalent or identical with any of these
5 substances, but not including decocainized coca leaves
6 or extractions which do not include cocaine or ecgonine.

7 (2) any of the following opiates, including their
8 immediate isomers, esters, ethers, salts, and salts of
9 isomers, esters, and ethers, unless specifically
10 excepted, whenever the existence of such isomers,
11 esters, ethers, and salts is possible within the
12 specific chemical designation:

13 (a) alphaprodine,

14 (b) anileridine,

15 (c) apomorphine,

16 (d) bezitramide,

17 (e) dihydrocodeine,

18 (f) diphenoxylate,

19 (g) fentanyl,

20 (h) isomethadone,

21 (i) levomethorphan,

22 (j) levorphanol,

23 (k) metazocine,

24 (l) methadone,

25 (m) methadone, intermediate, 4-cyano-2-

- 1 dimethylamino-4, 4-diphenyl butane,
2 (n) methaqualone,
3 (o) moramide, intermediate, 2-methyl-3-
4 morpholino-1, 1-diphenyl-propane-carboxylic acid,
5 (p) pethidine,
6 (q) pethidine, intermediate, A, 4-cyano-1-methyl-
7 4-phenylpiperidine,
8 (r) pethidine, intermediate, B, ethyl-4-
9 phenylpiperidine; 4-carboxylate,
10 (s) pethidine, intermediate, C, 1-methyl-4-
11 phenylpiperidine-4-carboxylic acid,
12 (t) phenazocine,
13 (u) piminodine,
14 (v) racemethorphan, and
15 (w) racemorphan;
- 16 (3) any material, compound, mixture, or preparation
17 which contains any quantity of the following substances
18 having a potential for abuse associated with a stimulant
19 effect on the central nervous system:
- 20 (a) amphetamine, its salts, optical isomers, and
21 salts of its optical isomers;
- 22 (b) any substance which contains any quantity of
23 methamphetamine, including its salts, isomers, and salts
24 of isomers;
- 25 (c) any material, compound, mixture, or

1 preparation which contains any quantity of the following
2 substances having a potential for abuse associated with
3 a stimulant effect on the central nervous system:

- 4 (i) phenmetrazine and its salts;
5 (ii) methylphenidate;
6 (iii) gamma-hydroxybutyric acid."

7 Section 2. Section 1125 of title 11 of the Code of the
8 Federated States of Micronesia, as amended, is hereby amended to
9 read as follows:

10 "Section 1125 Schedule IV - Designated.

11 The controlled substances listed in this section are
12 included in schedule IV:

13 (1) any material, compound, mixture, or preparation
14 which contains any quantity of the following substances
15 or salts thereof having a potential for abuse associated
16 with a depressant effect on the central nervous system:

- 17 (a) barbital,
18 (b) benzodiazepines,
19 (c) chloral betaine,
20 (d) chloral hydrate,
21 (e) diethylpropion,
22 (f) ethchlorvynol,
23 (g) ethinamate,
24 (h) fenfluramine,
25 (i) methohexital,

- 1 (j) meprobamate,
 - 2 (k) methylphenobarbital,
 - 3 (l) paraldehyde,
 - 4 (m) petrichloral,
 - 5 (n) phenobarbital,
 - 6 (o) tramadol; and
 - 7 (p) zolpidem.

8 (2) The director may except by rule any compound,
9 mixture, or preparation containing any depressant
10 substance listed in subsection (1) of this section from
11 the application of all or any part of this chapter if
12 the compound, mixture, or preparation contains one or
13 more active medicinal ingredients not having a
14 depressant effect on the central nervous system, and if
15 the admixtures are included therein in combinations,
16 quantity, proportion, or concentration that vitiate the
17 potential for abuse of the substances which have a
18 depressant effect on the central nervous system."

19 Section 3. Effective date. This act shall become law upon
20 approval by the President of the Federated States of Micronesia
21 or upon its becoming law without such approval.
