

A BILL FOR AN ACT

To further amend Public Law No. 18-70, as previously amended by Public Laws Nos. 18-98, 18-112, 18-122, 19-07, 19-24, 19-41, 19-52, 19-73, 19-82, 19-101, 19-114, and 19-139, by amending section 2 and 6 thereof, to change the use of certain funds previously appropriated therein, for the purpose of funding public projects and social programs for the people of Yap State, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 2 of Public Law No. 18-170, as amended by
2 Public Laws Nos. 18-98, 18-112, 19-24, 19-41, 19-52, 19-73, 19-82,
3 19-101, 19-114, and 19-139, is hereby further amended to read as
4 follows:

5 "Section 2. Of the sum of \$5,100,000 appropriated by
6 this act, \$750,000 is apportioned for public projects and
7 social programs in the state of Yap.

8 Section 2. Section 6 of Public Law No. 18-70, as amended by
9 Public Laws Nos. 18-98, 18-112, 18-122, 19-07, 19-24, and 19-101
10 is hereby further amended to read as follows:

11 "Section 6. Allotment and management of funds and lapse
12 date. All funds appropriated by this act shall be
13 allotted, managed, administered and accounted for in
14 accordance with applicable laws, including, but not
15 limited to, the Financial Management Act of 1979. The
16 allottee shall be responsible for ensuring that these
17 funds, or so much thereof as may be necessary, are used
18 solely for the purpose specified in this act, and that no
19 obligations are incurred in excess of the sum
20 appropriated. The allottee of the funds appropriated
21 under section 2 of this act shall be the Governor of Yap
22 State EXCEPT THAT the funds appropriated under subsection
23 2(i) shall be the President of COM-FSM. The allottee of
24 funds appropriated under sections 3 and 4 of this act
25 shall be the President of the Federated States of

1 Micronesia or his designee EXCEPT THAT the funds
2 appropriated under subsections a, b, c, d, e, f, g, h, i,
3 j, k, l, m, n, o, s, t, u, v, w, x, ag, ah, aj, ap and aq
4 of section 3 this act shall be the Mayor of Lelu Town
5 Government or his designee; the funds appropriated under
6 subsections a, b, c, d, e, f and g of section 4(1),
7 subsections 4(3)(b), (c), (d), (f) and (p) of this act
8 shall the Pohnpei Transportation Authority, and the funds
9 appropriated under subsection 4(3)(t) shall be the
10 Luhkenmoanlap of Kitti. The allottee of funds
11 appropriated under subsections 5(1), 5(3) and 5(6), of
12 this act shall be the Governor of Chuuk State or his
13 designee. The allottee of funds appropriated under
14 subsection 5(2) of this act shall be the Mortlock Islands
15 Development Authority. The allottee of funds
16 appropriated under subsection 5(4) of this act shall be
17 the Southern Namoneas Development Authority. The
18 allottee of funds appropriated under subsection 5(5) of
19 this act shall be the Faichuk Development Authority. The
20 authority of the allottee to obligate funds appropriated
21 by this act shall lapse on September 30, [~~2017~~] 2018."

1 Section 3. This act shall become law upon approval by the
2 President of the Federated States of Micronesia or upon its
3 becoming law without such approval.
