
A BILL FOR AN ACT

To further amend Public Law No. 19-64, as amended by Public Laws Nos. 19-81, 19-97, 19-120 and 19-137, by amending section 2 thereof, to change the lapse date of funds previously appropriated therein, for the purpose of funding public projects and social programs in the states of Kosrae and Pohnpei, to correct technical errors, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section [4] 2 of Public Law No. 19-64, as
2 amended by Public Laws Nos. 19-81 and 19-97, is hereby further
3 amended to read as follows:

4 "Section [4] 2. Allotment and management of funds and
5 lapse date. All funds appropriated by this act shall
6 be allotted, managed, administered and accounted for
7 in accordance with applicable laws, including, but not
8 limited to, the Financial Management Act of 1979. The
9 allottee shall be responsible for ensuring that these
10 funds, or so much thereof as may be necessary, are
11 used solely for the purpose specified in this act, and
12 that no obligations are incurred in excess of the sum
13 appropriated. The allottee of the funds appropriated
14 under section 1 of this act shall be the President of
15 the Federated States of Micronesia or his designee;
16 PROVIDED THAT, the funds appropriated under
17 subsections 1(d) shall be the Mayor of Lelu Town

1 Government or his designee; the allottee of funds
2 appropriated under subsections 1(2)(1)(a)-(o),
3 1(2)(2)(a), 1(2)(2)(c), 1(2)(3)(a), 1(2)(3)(b),
4 1(2)(3)(d), 1(2)(3)(f) – (j), 1(2)(3)(l), 1(2)(3)(n),
5 1(2)(3)(q), 1(2)(4)(a)-(j) shall be the Pohnpei
6 Transportation Authority (PTA); the allottee of funds
7 appropriated under subsections 1(2)(2)(b), 1(2)(2)(d),
8 1(2)(2)(e) and 1(2)(2)(f) shall be the Secretary of
9 the Department of Transportation, Communication and
10 Infrastructure or his designee; the allottee of funds
11 appropriated under subsections 1(2)(2)(g), 1(2)(2)(h)
12 and 1(2)(3)(m) shall be the Pohnpei Utility
13 Corporation; the allottee of fund appropriated under
14 subsections 1(2)(4)(k)-(s) shall be the Governor of
15 the State of Pohnpei. The authority of the allottee
16 to obligate funds appropriated by this act shall lapse
17 on September 30, [~~2017~~] 2018.”

18 Section 2. This act shall become law upon approval by the
19 President of the Federated States of Micronesia or upon its
20 becoming law without such approval.
