

A BILL FOR AN ACT

To appropriate the sum of \$4,200,000 from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 2017, for the purpose of funding public projects and social programs for the people of Yap, Kosrae, Pohnpei and Chuuk States, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. The sum of \$4,200,000, or so much thereof as
2 may be necessary, is hereby appropriated from the General Fund
3 of the Federated States of Micronesia for the fiscal year
4 ending September 30, 2017, for the purpose of funding public
5 projects and social programs for the people of Yap, Kosrae,
6 Pohnpei and Chuuk States. The fund shall be apportioned as
7 follows:

8 Section 2. Of the sum of \$4,200,000 appropriated by this
9 act, \$600,000 is apportioned for Yap State for public projects
10 and social programs.

11 state of Yap\$ 600,000

12 Section 3. Of the sum of \$4,200,000 appropriated by
13 this act, \$600,000 is apportioned for Kosrae State for
14 public projects and social programs.

15 state of Kosrae 600,000

16 Section 4. Of the sum of \$4,200,000 appropriated by this
17 act, \$1,200,000 is apportioned for Pohnpei State for public
18 projects and social programs.

6 Section 5. Of the sum of \$4,200,000 appropriated by this
 7 act, \$1,800,000 is apportioned for Chuuk State for public
 8 projects and social programs.

16 Section 6. Allotment and management of funds and lapse
 17 date. All funds appropriated by this act shall be allotted,
 18 managed, administered and accounted for in accordance with
 19 applicable laws, including, but not limited to, the Financial
 20 Management Act of 1979. The allottee shall be responsible for
 21 ensuring that these funds, or so much thereof as may be
 22 necessary, are used solely for the purpose specified in this
 23 act, and that no obligations are incurred in excess of the sum
 24 appropriated. The allottee of the funds appropriated under
 25 section 2 of this act shall be the Governor of Yap State or his

1 designee. The allottee of funds appropriated under sections 3
2 and 4 of this act shall be the President of the Federated
3 States of Micronesia or his designee. The allottee of funds
4 appropriated under subsections 5(1), 5(3) and 5(6) of this act
5 shall be the Governor of Chuuk State or his designee. The
6 allottee of funds appropriated under subsection 5(2) of this
7 act shall be the Mortlock Islands Development Authority. The
8 allottee of funds appropriated under subsection 5(4) of this
9 act shall be the Southern Namoneas Development Authority. The
10 allottee of funds appropriated under subsection 5(5) of this
11 act shall be the Faichuk Development Authority. The authority
12 of the allottee to obligate funds appropriated by this act
13 shall lapse on September 30, 2019.

14 Section 7. This act shall become law upon approval by the
15 President of the Federated States of Micronesia or upon its
16 becoming law without such approval.
