A BILL FOR AN ACT

To further amend Public Law No. 19-64, as amended by Public Laws Nos. 19-81, 19-97, 19-120, 19-137 and 20-29 by amending section 2 thereof, to change the lapse date of funds previously appropriated therein, for the purpose of funding public projects and social programs in the states of Kosrae and Pohnpei, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1           Section 1. Section 2 of Public Law No. 19-64, as amended  
2 by Public Laws Nos. 19-81, 19-97 and 20-29, is hereby further  
3 amended to read as follows:

4           "Section 2. Allotment and management of funds and  
5 lapse date. All funds appropriated by this act shall  
6 be allotted, managed, administered and accounted for  
7 in accordance with applicable laws, including, but  
8 not limited to, the Financial Management Act of 1979.  
9 The allottee shall be responsible for ensuring that  
10 these funds, or so much thereof as may be necessary,  
11 are used solely for the purpose specified in this  
12 act, and that no obligations are incurred in excess  
13 of the sum appropriated. The allottee of the funds  
14 appropriated under section 1 of this act shall be the  
15 President of the Federated States of Micronesia or  
16 his designee; PROVIDED THAT, the funds appropriated  
17 under subsections 1(d) shall be the Mayor of Lelu  
18 Town Government or his designee; the allottee of

1 funds appropriated under subsections 1(2)(1)(a)-(o),  
2 1(2)(2)(a), 1(2)(2)(c), 1(2)(3)(a), 1(2)(3)(b),  
3 1(2)(3)(d), 1(2)(3)(f) – (j), 1(2)(3)(l), 1(2)(3)(n),  
4 1(2)(3)(q), 1(2)(4)(a)-(j) shall be the Pohnpei  
5 Transportation Authority (PTA); the allottee of funds  
6 appropriated under subsections 1(2)(2)(b),  
7 1(2)(2)(d), 1(2)(2)(e) and 1(2)(2)(f) shall be the  
8 Secretary of the Department of Transportation,  
9 Communication and Infrastructure or his designee; the  
10 allottee of funds appropriated under subsections  
11 1(2)(2)(g), 1(2)(2)(h) and 1(2)(3)(m) shall be the  
12 Pohnpei Utility Corporation; the allottee of fund  
13 appropriated under subsections 1(2)(4)(k)-(s) shall  
14 be the Governor of the State of Pohnpei. The  
15 authority of the allottee to obligate funds  
16 appropriated by this act shall lapse on September 30,  
17 [~~2018~~] 2019.”

18 Section 2. This act shall become law upon approval by the  
19 President of the Federated States of Micronesia or upon its  
20 becoming law without such approval.
