

AN ACT

To amend section 1 of Public Law No. 1-118, as amended by Public Law No. 1-125, No. 1-125, to provide supplemental funding for National Government programs during fiscal year 1981 by increasing the amount previously appropriated to \$2,411,200, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 1 of Public Law No. 1-118, as amended by Public
2 Law No. 1-125, is hereby further amended to read as follows:

3 "Section 1. The sum of \$2,411,200, or so much thereof as may
4 be necessary, is hereby appropriated from the General Fund of
5 the Federated States of Micronesia for the executive branch,
6 national judiciary, Public Auditor and other programs of the
7 National Government of the Federated States of Micronesia for
8 Fiscal Year 1981. The sum appropriated by this act shall be
9 apportioned as follows:


