CONGRESSIONAL BILL NO. 7-154, C.D.1

AN ACT

To appropriate the sum of \$1,000,000 from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 1992, for the purpose of funding public projects in the State of Kosrae, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. The sum of \$1,000,000, or so much thereof as may be
2 necessary, is hereby appropriated from the General Fund of the
3 Federated States of Micronesia for the fiscal year ending September
4 30, 1992, for the purpose of funding public projects in the State of
5 Kosrae. The sum appropriated by this section shall be apportioned as
6 follows:

 - 14 (4) Malem municipal projects..... 92,000
 - 15 (5) Utwe municipal projects..... 74,000
 - 16 (6) Statewide projects
 - 17 (a) Bukusrik River bridge..... 21,600
 - 18 (b) KCAP aluminum recycling project..... 20,000
 - 19 (c) Split-type air conditioner system for
20 V6AJ broadcast station..... 6,000
 - 21 (d) Kosrae old age group project..... 10,000
 - 22 (e) September 8th activities..... 4,000


1 (7) Airport and dock water system..... \$500,000

2 Section 2. All funds appropriated by this act shall be allotted,
3 managed, administered, and accounted for in accordance with applicable
4 law, including, but not limited to, the Financial Management Act of
5 1979. The allottee of the funds appropriated under subsections (1),
6 (2), (3), (4) and (5) of section 1 of this act shall be the chairman
7 of the KSCIP; the allottee of the funds appropriated under
8 subsections (6) and (7) of section 1 of this act shall be the
9 Governor of Kosrae State. The allottees shall be responsible for
10 ensuring that these funds, or so much thereof as may be necessary,
11 are used solely for the purposes specified in this act, and that no
12 obligations are incurred in excess of the sum appropriated. The
13 authority of the allottees to obligate funds appropriated by this act
14 shall not lapse.

15 Section 3. This act shall become law upon approval by the
16 President of the Federated States of Micronesia or upon its becoming
17 law without such approval.
