

AN ACT

To amend Public Law No. 7-29, Kosrae State public projects, by amending sections 1 and 2 to allocate the use of funds previously appropriated therein and to modify the allottee of certain funds previously appropriated therein, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 1 of Public Law No. 7-29 is hereby amended  
2 to read as follows:

3 "Section 1. The sum of \$1,000,000, or so much thereof as  
4 may be necessary, is hereby appropriated from the General  
5 Fund of the Federated States of Micronesia for the fiscal  
6 year ending September 30, 1992, for the purpose of funding  
7 public projects in the State of Kosrae. The sum  
8 appropriated by this section shall be apportioned as  
9 follows:

  - 11 (a) Personnel.....\$ 5,000
  - 12 (b) Travel..... 2,000
  - 13 (c) Consumable goods..... 14,000
  - 14 (d) Contractual services..... 9,400
- 15 (2) Lelu municipal projects
  - 16 (a) Road construction equipment  
17 and parts..... 68,000
  - 18 (b) Water system maintenance..... 12,000
  - 19 (c) Farm project..... 42,000
- 20 (3) Tafunsak municipal projects
  - 21 (a) Road construction equipment  
22 and parts ..... 120,000

16           Section 2. Section 2 of Public Law No. 7-29 is hereby amended  
17 to read as follows:

18           "Section 2. All funds appropriated by this act shall be  
19 allotted, managed, administered, and accounted for in  
20 accordance with applicable law, including, but not limited  
21 to, the Financial Management Act of 1979. The allottee of  
22 the funds appropriated under subsections (1), (2), (3),  
23 (4), (5) and (6)(e) of section 1 of this act shall be  
24 the chairman of the KSCIP; the allottee of the funds  
25 appropriated under subsections (6)(a), (6)(b), (6)(c),

1 (6)(d) and (7) of section 1 of this act shall be the  
 2 Governor of Kosrae State. The allottees shall be  
 3 responsible for ensuring that these funds, or so much  
 4 thereof as may be necessary, are used solely for the  
 5 purposes specified in this act, and that no obligations are  
 6 incurred in excess of the sum appropriated. The authority  
 7 of the allottees to obligate funds appropriated by this act  
 8 shall not lapse."

9 Section 3. This act shall become law upon approval by the  
 10 President of the Federated States of Micronesia or upon its becoming  
 11 law without such approval.
