A BILL FOR AN ACT

To amend Public Law No. 8-115, by amending section 5, for the purpose of changing the allottee of funds for the district of the Northwest Islands in the State of Chuuk, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:


1 Section 1. Section 5 of Public Law No. 8-115 is hereby amended to
2 read as follows:

3 "Section 5. All funds appropriated by this act shall be
4 allotted, managed, administered, and accounted for in
5 accordance with applicable law, including, but not limited to,
6 the Financial Management Act of 1979. The allottee of the
7 funds appropriated by subsections (1) and (6) of section 1 of
8 this act shall be the Chuuk State Director of Health Services.
9 The allottee of the funds appropriated by subsection (2) of
10 section 1 of this act shall be the Southern Namoneas
11 Development Authority. The allottee of the funds appropriated
12 by subsection (3) of section 1 of this act shall be the Pattiw
13 Development Authority. The allottee of the funds appropriated
14 by subsections ~~177~~ (4) and (5) of section 1 of this act shall
15 be the Secretary of the Department of Health Services of the
16 Federated States of Micronesia or his designee. The allottee
17 of the funds appropriated by section 2 of this act shall be
18 the Governor of Kosrae or his designee. ~~777~~ The allottee of
19 all other funds appropriated by this act shall be the
20 President of the Federated States of Micronesia or his ~~777~~
21 ~~President~~ designee. The allottees shall be responsible for
22 ensuring that these funds, or so much thereof as may be
23 necessary, are used solely for the purpose specified in this
24 act, and that no obligations are incurred in excess of the sum
25 appropriated. The authority of the allottees to obligate

3 Section 2. This act shall become law upon approval by the


