NINTH CONGRESS OF THE FEDERATED STATES OF MICRONESIA

FIRST SPECIAL SESSION, 1995

CONGRESSIONAL BILL NO. 9-70, C.D.1

AN ACT

To appropriate the sum of \$750,000 from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 1995, for medical supplies, equipment, referral programs, and construction and renovation of dispensaries in all of the four States of the Federated States of Micronesia, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. The sum of \$400,000, or so much thereof as may be
2 necessary, is hereby appropriated from the General Fund of the Federated
3 States of Micronesia for the fiscal year ending September 30, 1995, for medical
4 supplies, equipment, referral programs, and construction and renovation of
5 dispensaries in the State of Chuuk to be apportioned as follows:

6	(1) Chuuk Hospital	\$ 130,000
7	(2) Faichuk.....	65,000
8	(3) Southern Namoneas	65,000
9	(4) Northern Namoneas	55,000
10	(5) Mortlocks.....	50,000
11	(6) Northwest Islands.....	35,000

12 Section 2. The sum of \$200,000, or so much thereof as may be
13 necessary, is hereby appropriated from the General Fund of the Federated
14 States of Micronesia for the fiscal year ending September 30, 1995, for
15 pharmaceutical supplies, lab and dental equipment, and referral programs in
16 the State of Pohnpei.

17 Section 3. The sum of \$100,000, or so much thereof as may be
18 necessary, is hereby appropriated from the General Fund of the Federated
19 States of Micronesia for the fiscal year ending September 30, 1995, for medical
20 supplies, equipment, and referral programs in the State of Yap.

21 Section 4. The sum of \$50,000, or so much thereof as may be
22 necessary, is hereby appropriated from the General Fund of the Federated

1 States of Micronesia for medical supplies, equipment, and referral programs in
2 the State of Kosrae.

3 Section 5. All funds appropriated by this act shall be allotted, managed,
4 administered, and accounted for in accordance with applicable law, including, but
5 not limited to, the Financial Management Act of 1979. All funds appropriated
6 herein shall not lapse until fully expended. The allottee of funds appropriated
7 under subsection (1) of section 1 of this act shall be the Director of Health
8 Services, Chuuk State. The allottee of funds appropriated under subsection (2)
9 of section 1 of this act shall be the PWP Authority. The allottee of funds
10 appropriated under subsection (3) of section 1 of this act shall be the
11 Southern Namoneas Authority. The allottee of funds appropriated under
12 subsection (4) of section 1 of this act shall be the Northern Namoneas
13 Development Authority. The allottee of funds appropriated under subsection
14 (5) of section 1 of this act shall be the Mortlocks Development Authority. The
15 allottee of funds appropriated under subsection (6) of section 1 of this act
16 shall be the Pattiw Development Authority. The allottee of funds appropriated
17 under section 2 of this act shall be the Governor of Pohnpei State. The allottee
18 of funds appropriated under section 3 of this act shall be the Governor of Yap
19 State. The allottee of funds appropriated under section 4 of this act shall be
20 the Governor of Kosrae State.
