A BILL FOR AN ACT

To amend Public Law No. 8-134 by amending section 2 to appropriate sum of \$100,000 from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 1995, for the purpose of funding a program of improvements to the local water supply system in Sekere in Sokehs Municipality, Pohnpei State, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:


1 Section 1. Section 2 of Public Law No. 8-134 is hereby amended to read  
2 as follows:

3 "Section 2. The sum of ~~\$200,000~~ 300,000, or so much thereof as  
4 may be necessary, is hereby appropriated from the General Fund of  
5 the Federated States of Micronesia for the fiscal year ending  
6 September 30, 1995, for the purpose of funding a local water  
7 system improvement program and ice plant construction in the  
8 State of Pohnpei. The funds appropriated by this act shall be  
9 apportioned as follows:

- 10 (1) Madolenihmw ice plant .....\$ 100,000
- 11 (2) Kitti ice plant ..... 100,000
- 12 (3) Sokehs, Sekere water system..... 100,000 "

13 Section 2. This act shall become law upon approval by the President of  
14 the Federated States of Micronesia or upon its becoming law without such  
15 approval.

AN ACT

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

6 September 30, 1995, for the purpose of funding a local water  
7 system improvement program and ice plant construction in the  
8 State of Pohnpei. The funds appropriated by this act shall be  
9 apportioned as follows:

- 10 (1) Madolenihmw ice plant/water development.....\$ 100,000
- 11 (2) Kitti ice plant/water development..... 100,000"

12 Section 2. This act shall become law upon approval by the President of  
13 the Federated States of Micronesia or upon its becoming law without such  
14 approval.
