A BILL FOR AN ACT

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 3 of Public Law No. 8-115 is hereby amended to read  
2 as follows:

4 may be necessary, is hereby appropriated from the General Fund of  
5 the Federated States of Micronesia for the fiscal year ending  
6 September 30, 1995, for the purpose of financing the construction  
7 of ~~the~~ a super ~~dispensary~~ dispensary in Nett Municipality in  
8 the State of Pohnpei. ~~The sum of \$100,000 is hereby appropriated~~
