A BILL FOR AN ACT

To further amend Public Law No. 8-100, as amended by Public Laws Nos. 8-121 and 9-011, by amending section 3, as amended by Public Law No. 9-011, to change the use of certain funds appropriated for educational needs other than travel or vehicles in Election District No. 3 of Pohnpei State, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 3 of Public Law No. 8-100, as amended by
2 Public Law No. 9-011, is hereby further amended to read as follows:

3 "Section 3. The sum of \$1,000,000, or so much thereof as may
4 be necessary, is hereby appropriated from the General Fund of
5 the Federated States of Micronesia for the fiscal year ending
6 September 30, 1995, for educational needs, other than travel,
7 and/or vehicles, in the State of Pohnpei. The funds
8 appropriated under section 3 of this act shall be apportioned
9 as follows:


