A BILL FOR AN ACT

To further amend Public Law No. 6-89, Kosrae State public projects, as amended, by further amending section 2, as amended by Public Laws Nos. 7-7, 7-95 and 8-57, to modify the use of certain funds previously appropriated therein, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 2 of Public Law No. 6-89, as amended by Public Laws  
2 Nos. 7-7, 7-95 and 8-57, is hereby further amended to read as follows:
