A BILL FOR AN ACT

To appropriate the sum of \$1,500,000 from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 1996, for the purpose of purchasing four emergency crash, fire and rescue vehicles, and other costs associated therewith, for the international airports in the States of Chuuk, Kosrae, Pohnpei and Yap, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. The sum of \$1,500,000, or so much thereof as may be
2 necessary, is hereby appropriated from the General Fund of the Federated
3 States of Micronesia for the fiscal year ending September 30, 1996, for the
4 purpose of purchasing four emergency crash, fire and rescue vehicles, to be
5 stationed at the four international airports in the Federated States of
6 Micronesia, one of which is located in each of the States of Chuuk, Kosrae,
7 Pohnpei and Yap.

8 Section 2. All funds appropriated by this act shall be allotted,
9 managed, administered, and accounted for in accordance with applicable law,
10 including, but not limited to, the Financial Management Act of 1979. The
11 allottee of the funds appropriated by this act shall be the President of the
12 Federated States of Micronesia or the President's designee. The allottee
13 shall be responsible for ensuring that these funds, or so much thereof as
14 may be necessary, are used solely for the purpose specified in this act, and
15 that no obligations are incurred in excess of the sum appropriated. The
16 authority of the allottee to obligate funds appropriated by this act shall
17 not lapse.

18 Section 3. This act shall become law upon approval by the
19 President of the Federated States of Micronesia or upon its becoming
20 law without such approval.

A BILL FOR AN ACT

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. The sum of \$1,500,000, or so much thereof as
2 may be necessary, is hereby ~~appropriated~~ authorized for
3 appropriation from the General Fund of the Federated States of
4 Micronesia for the fiscal year ending September 30, ~~1996~~ 1997,
5 for the purpose of purchasing four emergency crash, fire and
6 rescue vehicles, to be stationed at the four international
7 airports in the Federated States of Micronesia, one of which is
8 located in each of the States of Chuuk, Kosrae, Pohnpei, and
9 Yap.

10 Section 2. The allottee of the funds appropriated by
11 section 1 of this act shall not obligate funds for the purchase
12 of a crash, fire and rescue vehicle for use in the
13 international airport of any state until the state has
14 demonstrated to the allottee's satisfaction pursuant to the
15 terms of memoranda of understanding entered into between the
16 National Government and the relevant state authorities that
17 the state has made ready and available, (1) properly and
18 adequately trained operators, maintenance personnel, mechanics,
19 and any other staff the allottee deems necessary for the
20 operation and of the vehicle; and (2) a properly and adequately
21 designed and built garage facility for the vehicle that will
22 protect it from the elements when not in use.

23 Section 3. The National Government shall retain title to
24 any vehicles purchased with funds appropriated by this act.
25 Each state receiving any vehicle purchased with funds
