A BILL FOR AN ACT

To further amend Public Law No. 9-052, as amended by Public Laws Nos. 9-071, 9-086 and 9-094, by amending section 4, as amended by Public Law No. 9-086, to modify the use of certain monies appropriated therein, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:


1 Section 1. Section 4 of Public Law No. 9-052, as amended by
2 Public Law No. 9-086, is hereby further amended to read as follows:
3 "Section 4. The sum of \$2,500,000, or so much thereof as
4 may be necessary, is hereby appropriated from the General
5 Fund of the Federated States of Micronesia for the fiscal
6 year ending September 30, 1996, for the purpose of funding
7 infrastructure needs, transportation systems, and other
8 economic and social projects, public projects and for other
9 purposes in Yap State. The funds appropriated under this
10 section shall be apportioned as follows:

11	(1) Yap International Airport	\$1,000,000
12	(2) Outer Islands - airports and terminals ..	680,000
13	(3) Amun power and water	35,000
14	(4) Meerur power and water	10,000
15	(5) Maap Elementary School water catchment ..	17,000
