A BILL FOR AN ACT

To appropriate the sum of \$1,150,000 from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 1997, for the purpose of funding hospital needs of the States of Chuuk, Kosrae, Pohnpei and Yap, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. The sum of \$500,000, or so much thereof as
2 may be necessary, is hereby appropriated from the General Fund
3 of the Federated States of Micronesia for the fiscal year
4 ending September 30, 1997, for the purpose of funding the
5 hospital needs of the State of Chuuk.

6 Section 2. The sum of \$100,000, or so much thereof as
7 may be necessary, is hereby appropriated from the General Fund
8 of the Federated States of Micronesia for the fiscal year
9 ending September 30, 1997, for the purpose of funding the
10 hospital needs of the State of Kosrae.

11 Section 3. The sum of \$300,000, or so much thereof as
12 may be necessary, is hereby appropriated from the General Fund
13 of the Federated States of Micronesia for the fiscal year
14 ending September 30, 1997, for the purpose of funding the
15 hospital needs of the State of Pohnpei.


16 Section 4. The sum of \$250,000, or so much thereof as
17 may be necessary, is hereby appropriated from the General Fund
18 of the Federated States of Micronesia for the fiscal year
19 ending September 30, 1997, for the purpose of funding outer
20 island health care centers in the State of Yap, including
21 acquisition of land, equipment, supplies, and pharmaceuticals,
22 but not including travel other than on the most direct
23 available route between Yap proper and a center site.

24 Section 5. All funds appropriated by this act shall be
25 allotted, managed, administered, and accounted for in

1 accordance with applicable law, including, but not limited to,
 2 the Financial Management Act of 1979. The allottee of the
 3 funds appropriated under section 4 of this act shall be the
 4 Governor of the State of Yap, who shall not obligate any funds
 5 appropriated therein without first consulting with the Yap
 6 Delegation to the Congress of the Federated States of
 7 Micronesia. The allottee of all other funds appropriated by
 8 this act shall be the President of the Federated States of
 9 Micronesia or the President's designee. The allottees shall be
 10 responsible for ensuring that these funds, or so much thereof
 11 as may be necessary, are used solely for the purpose specified
 12 in this act, and that no obligations are incurred in excess of
 13 the sum appropriated. The authority of the allottees to
 14 obligate funds appropriated by this act shall lapse as of
 15 September 30, 1998.

16 Section 6. This act shall become law upon approval by
 17 the President of the Federated States of Micronesia or
 18 upon its becoming law without such approval.
