A BILL FOR AN ACT

To appropriate the sum of \$23,000 from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 1997, for the purpose of funding the position of Chief of Staff in the Office of the President, and to amend section 14 of Public Law No. 9-096 to add to the employment ceiling for the Office of the President, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

- Section 1. The sum of \$23,000, or so much thereof as may be
- 2 necessary, is hereby appropriated from the General Fund of the Federated
- 3 States of Micronesia for the fiscal year ending September 30, 1997, for
- 4 the purpose of funding the position of Chief of Staff in the Office of
- 5 the President.

- 8 "Section 14. Employment ceilings. Subsection (1) sets forth the
- 9 maximum number of positions that may be hired by branches and

- 2 the Federated States of Micronesia or the President's designee. The
- 3 allottee shall be responsible for ensuring that these funds, or so much
- 4 thereof as may be necessary, are used solely for the purpose specified in
- 5 this act, and that no obligations are incurred in excess of the sum
- 6 appropriated. The authority of the allottee to obligate funds
- 7 appropriated by this act shall lapse as of September 30, 1997.
- 8 Section 4. This act shall become law upon approval by the
- 9 President of the Federated States of Micronesia or upon its becoming law
- 10 without such approval.
