

A BILL FOR AN ACT

To further amend Public Law No. 9-100, as amended by Public Laws Nos. 9-104, 9-129, and 9-137, by further amending section 1, as amended by Public Laws Nos. 9-104 and 9-129, to reallocate certain funds appropriated therein for public projects and programs in the State of Chuuk, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 1 of Public Law No. 9-100, as amended by Public
2 Laws Nos. 9-104 and 9-129, is hereby further amended to read as follows:

3 "Section 1. The sum of \$5,350,000, or so much thereof as
4 may be necessary, is hereby appropriated from the General
5 Fund of the Federated States of Micronesia for the fiscal year
6 ending September 30, 1997, for the purpose of funding the
7 infrastructure, social and economic development and other
8 needs of the State of Chuuk. The funds appropriated by this
9 section shall be apportioned as follows:
