A BILL FOR AN ACT

To further amend Public Law No. 8-93, as amended by Public Laws Nos. 8-98, 8-123, 8-137, 9-020, and 9-098, by further amending section 2, as amended by Public Laws Nos. 8-98, 8-123, 8-137, 9-020, and 9-098, for the purpose of changing an allottee of funds, and for other purposes.


BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 2 of Public Law No. 8-93, as amended  
2 by Public Laws Nos. 8-98, 8-123, 8-137, 9-020, and 9-098, is  
3 hereby further amended to read as follows:

4 "Section 2. All funds appropriated by this act  
5 shall be allotted, managed, administered and  
6 accounted for in accordance with applicable law,  
7 including, but not limited to, the Financial  
8 Management Act of 1979. The allottee of the funds  
9 appropriated under subsections (1)(a)(i),  
10 (1)(a)(ii), and (1)(a)(iii) of section 1 of this act  
11 shall be the Tolensom Authority. The allottee of  
12 the funds appropriated under subsection (1)(b) of  
13 section 1 of this act shall be the Northern Namoneas  
14 Development Authority. The allottee of the funds  
15 appropriated under subsection (1)(c) of section 1 of  
16 this act shall be the Southern Namoneas Development  
17 Authority. The allottee of the funds appropriated  
18 under subsection (1)(d)(i) and (1)(d)(ii) of section  
19 1 of this act shall be the Northwest Islands Project  
20 Coordinator ~~FACILITY DEVELOPMENT AUTHORITY~~. The  
21 allottee of the funds appropriated under subsection  
22 (1)(e)(xiii) of section 1 of this act shall be the  
23 Lower Mortlocks Development Authority. The allottee  
24 of the funds appropriated under subsection (4) of  
25 section 1 of this act shall be the Governor of the

1 State of Yap or his designee. The allottee of all  
 2 other funds appropriated by this act shall be the  
 3 President of the Federated States of Micronesia or  
 4 the President's designee. The allottees shall be  
 5 responsible for ensuring that these funds, or so  
 6 much thereof as may be necessary, are used solely  
 7 for the purposes specified in this act, and that no  
 8 obligations are incurred in excess of the sum  
 9 appropriated. The authority of the allottees to  
 10 obligate funds appropriated by this act shall not  
 11 lapse."

12 Section 2. This act shall become law upon approval by  
 13 the President of the Federated States of Micronesia or upon its  
 14 becoming law without such approval.
