AN ACT

To appropriate the sum of \$200,000 from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 2018, for the purpose of funding relief efforts in Guam and the Commonwealth of the Northern Mariana Islands due to damages caused by Typhoon Mangkhut, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. The sum of \$200,000, or so much thereof as may
2 be necessary, is hereby appropriated from the General Fund of
3 the Federated States of Micronesia for the fiscal year ending
4 September 30, 2018, for the purpose of funding relief efforts
5 in Guam and the Commonwealth of the Northern Mariana Islands
6 due to damages caused by Typhoon Mangkhut. The funds
7 appropriated under this section shall be apportioned as
8 follows:

9 1. Guam Typhoon Mangkhut relief\$ 100,000
10 2. Commonwealth of the Northern Mariana
11 Islands Typhoon Mangkhut relief 100,000

12 Section 2. Allotment and management of funds and lapse
13 date. All funds appropriated by this act shall be allotted,
14 managed, administered and accounted for in accordance with
15 applicable laws, including, but not limited to, the Financial
16 Management Act of 1979. The allottee shall be responsible for
17 ensuring that these funds, or so much thereof as may be
18 necessary, are used solely for the purpose specified in this

1 act, and that no obligations are incurred in excess of the sum
2 appropriated. The allottee of the funds appropriated under
3 section 1 of this act shall be the President of the Federated
4 States of Micronesia or his designee. The authority of the
5 allottee to obligate such funds shall lapse on September 30,
6 2019 and any unallotted funds will revert back to the General
7 Fund.

8 Section 3. This act shall become law upon approval by the
9 President of the Federated States of Micronesia or upon its
10 becoming law without such approval.


